THE EDUCATION BOARDS' EMPLOYMENT REGULATIONS 1958, AMENDMENT NO. 4

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Education Boards' Employment Regulations 1958, Amendment No. 4, and shall be read together with and deemed part of the Education Boards' Employment Regulations 1958* (hereinafter referred to as the principal regulations).

2. The principal regulations are hereby amended by inserting, after regulation 25, the following heading and regulation:

"Study Leave

"25A. (1) A Board may, upon such conditions as the Review Committee with the concurrence of the Minister may approve, grant to a whole-time officer special leave of absence to enable him to attend a course of study or training at a University or other educational institution, whether in New Zealand or elsewhere, in furtherance of his training as an officer of the Board. The conditions for the award of any such special leave may include the requirement that the whole-time officer granted special leave shall enter into a bond in a form approved by the Review Committee as security for compliance with conditions upon which the leave is granted.

"(2) Where leave of absence has been granted under the provisions of subclause (1) of this regulation, the Board may pay to the whole-time officer an amount (whether by way of allowance or in reimbursement of

3. (1) Part I of the Schedule to the principal regulations, as substituted by regulation 4 of the Education Boards' Employment Regulations 1958, Amendment No. 3, is hereby amended—

- (a) By omitting the symbol "4" where it appears in relation to the salary for the Ninth Step of Grade A:
- (b) By omitting Note 4 at the foot of the Salary Scale.

(2) This regulation shall be deemed to have come into force on the 1st day of April 1961.

4. (1) The Schedule to the principal regulations is hereby amended by revoking Part I, as substituted by regulation 4 of the Education Boards' Employment Regulations 1958, Amendment No. 3, and substituting the Part set out in the First Schedule to these regulations.

(2) This regulation shall be deemed to have come into force on the 1st day of October 1961.

5. (1) The Schedule to the principal regulations is hereby amended by revoking Part II, as substituted by regulation 5 of the Education Boards' Employment Regulations 1958, Amendment No. 3, and substituting the Part set out in the Second Schedule to these regulations.

(2) This regulation shall be deemed to have come into force on the 1st day of April 1961.

(3) This regulation and the Second Schedule to these regulations shall be deemed to have continued in force until the 30th day of September 1961 and to have then expired.

6. (1) The Schedule to the principal regulations is hereby amended by revoking Part II, as substituted by regulation 5 of these regulations, and substituting the Part set out in the Third Schedule to these regulations.

(2) This regulation shall be deemed to have come into force on the 1st day of October 1961.

(3) This regulation and the Third Schedule to these regulations shall be deemed to have continued in force until the 31st day of March 1962 and to have then expired.

7. (1) The Schedule to the principal regulations is hereby amended by revoking Part II, as substituted by regulation 6 of these regulations, and substituting the Part set out in the Fourth Schedule to these regulations.

(2) This regulation shall be deemed to have come into force on the 1st day of April 1962.

(3) This regulation and the Fourth Schedule to these regulations shall continue in force until the 31st day of March 1963 and shall then expire.

8. (1) The Schedule to the principal regulations is hereby amended by revoking Part II, as substituted by regulation 7 of these regulations, and substituting the Part set out in the Fifth Schedule to these regulations.

(2) This regulation shall come into force on the 1st day of April 1963.

9. (1) The Schedule to the principal regulations is hereby amended by revoking Parts III and IV, as substituted by regulation 5 of the Education Boards' Employment Regulations 1958, Amendment No. 3, and substituting the Parts set out in the Sixth Schedule to these regulations.

(2) This regulation shall be deemed to have come into force on the 1st day of October 1961.

10. Regulations 4 and 5 of the Education Boards' Employment Regulations 1958, Amendment No. 3, and the Schedules to those regulations, are hereby consequentially revoked.
