THE EDUCATION BOARD GRANTS REGULATIONS 1952, AMENDMENT NO. 5

Pursuant to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Education Board Grants Regulations 1952, Amendment No. 5, and shall be read together with and deemed part of the Education Board Grants Regulations 1952* (hereinafter referred to as the principal regulations).

2. Regulation 2 of the principal regulations, as amended by regulation 2 of the Education Board Grants Regulations 1952, Amendment No. 3, and by regulation 2 of the Education Board Grants Regulations 1952, Amendment No. 4, is further amended by revoking paragraphs (a) and (b), and substituting the following paragraphs:

"(a) A grant for general purposes comprising:

"(i) An amount determined in accordance with the following scale:

Number of Pupils on the Rolls of Public Schools in the District of the Education Board Ascertained in Accordance With These Regulations (Including Pupils on the Rolls of Intermediate Schools and Intermediate Departments Attached to District High Schools, and on the Rolls of Secondary Departments of District High Schools). - "(ii) An amount of £3 10s. for each student not enrolled under a post-primary teacher studentship who is on the roll of any training college controlled by the Education Board on the 1st day of March in the year in which the grant is made:
- "(b) A grant for the incidental expenses of the public schools (including intermediate schools) in the district of the Education Board, which grant shall be of an amount sufficient to provide for the payment of the cost of telephone rentals payable by School Committees in the district in accordance with paragraph (a) of subclause (2) of regulation 5 of the Education (School Committees Incidental Expenses) Regulations 1956 and for payment of a sum to be determined by the Minister, being a sum calculated according to the total number of pupils on the rolls of the said schools and being not less than 16s. 3d. and not more than £1 1s. 3d. for each such pupil, and which grant shall be paid by the Board to the School Committees in the district, except for an amount calculated at the rate of 3s. for each such pupil which shall be retained by the Education Board and applied towards providing the following services, namely:
 - "(i) The purchase of books for school and class libraries approved by the Senior Inspector, the provision of shelves, cupboards, or other appliances for the custody and care of the books, and the cost of exchanging library books between schools up to an amount of at least 2s. for each pupil:
 - "(ii) The supply of free class books and school stationery to pupils in cases where the Head Teacher certifies that the parents or guardians of the pupil are in necessitous circumstances and the Education Board approves the expenditure:
 - "(iii) The cost of teaching pupils to swim:
 - "(iv) The cost of journeys for special purposes under conditions approved by the Minister from time to time:
 - "(v) The supply of equipment and materials for the teaching of physical education, arts and crafts, social studies in history and geography, and nature study, in the schools:
 - "(vi) The supply of equipment and materials for use, on the recommendation of the Senior Inspector, in special classes, hospital classes, and schools at health camps, in occupation centres and speech clinics, and for any other services approved for the purpose of this paragraph by the Minister."
- **3.** Regulation 2 of the Education Board Grants Regulations 1952, Amendment No. 3, and the Education Board Grants Regulations 1952, Amendment No. 4, are hereby consequentially revoked.
- 4. Regulation 2 of the principal regulations, as amended by regulation 2 of the Education Board Grants Regulations 1952, Amendment No. 2, is hereby further amended by inserting in paragraph (f), after the words "teachers' and caretakers' residences", the words "(including detached garages and washhouses forming part thereof)".

5. Regulation 2 of the principal regulations is hereby amended by revoking paragraph (g), as set out in regulation 6 of the Education Board Grants Regulations 1952, Amendment No. 3, and substituting

the following paragraph:

"(g) A grant at the rate of £6 for each student not enrolled under a post-primary teacher studentship who is on the roll of any training college in the district of the Board on the 1st day of March in the year of the grant, of which grant £1 5s. shall be expended upon books for the library of the training college, and the balance shall be expended upon the teaching of swimming, class materials and equipment, expenses of museum classes, physical education, and other incidental expenses, the cost of office expenses (excluding office salaries) at the training college, and the medical examination of applicants for admission to the training college:

"Provided that the Minister may approve of the rate of the grant being increased by such amount as he thinks fit, but so that the amount of the grant shall not exceed £15 10s. for every such student who is a metalwork student or a woodwork student or £7 for every such student who is a homecraft

student."

6. Regulation 6 of the Education Board Grants Regulations 1952, Amendment No. 3, is hereby consequentially revoked.

7. Regulation 2 of the principal regulations is hereby amended by revoking paragraph (h), and substituting the following paragraph:

"(h) A grant of the actual cost of the salaries or wages of building inspectors engaged on the supervision of new building works, architects' assistants, draughtsmen, and workshops clerks, being in each case persons employed by the Board with the approval of the Director of Education, and, to the extent approved by the Director of Education, of the cost of the travelling expenses incurred by the said building inspectors."

8. Regulation 3 of the principal regulations and regulation 7 of the Education Board Grants Regulations 1952, Amendment No. 3 are hereby

revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations alter the amounts of certain of the grants payable to Education Boards and vary the circumstances in which the grants are payable.
