## THE EDUCATION BOARD GRANTS REGULATIONS 1965, AMENDMENT NO. 1

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. These regulations may be cited as the Education Board Grants Regulations 1965, Amendment No. 1, and shall be read together with and deemed part of the Education Board Grants Regulations 1965\* (hereinafter referred to as the principal regulations).

2. (1) Regulation 2 of the principal regulations is hereby amended by revoking paragraph (b) of subclause (1), and substituting the

following paragraph:

"(b) A grant for the incidental expenses of the State primary schools, including intermediate schools, under the control of the Board, which grant shall be of an amount sufficient to provide for the payment of the cost of telephone rentals payable by School Committees of those schools in accordance with paragraph (a) of subclause (2) of regulation 5 of the Education (School Committees Incidental Expenses) Regulations 1956† and for the payment of a sum to be determined by the Minister (being a sum calculated according to the total number of pupils on the rolls of the said schools, and being not less than £1 4s. 1d. and not more than £1 17s. 11d. for each such pupil), which sum shall (apart from such amount as the Board, after consultation with the Senior Inspector, may apply for the incidental expenses of special educational services, including special schools, classes, and services and general expenses of museum services) be paid by the Board to the School Committees of those schools, subject to the deduction of an amount (being an amount determined in like manner by the Minister and being not less than 4s. 6d. and not more than 5s. 9d. for each such pupil) to be retained by the Board for application towards providing the following services, namely:

"(i) The purchase of books for school and class libraries approved by the Senior Inspector and the cost of exchanging library books between schools to an amount not less than 3s. 9d. and not more than 5s. for each pupil:

"(ii) The supply of school stationery to pupils in cases where the Head Teacher certifies that the parents or guardians of the pupil are in necessitous circumstances and the

Board approves the expenditure:

"(iii) The cost of teaching pupils to swim:

"(iv) The cost of journeys for special purposes under con-

ditions approved by the Minister from time to time:

- "(v) The supply, after consultation with the Senior Inspector, of equipment, materials, and services (including the in-service training of teachers) for the teaching and development of the subjects of the curriculum of State primary schools:".
- (2) Notwithstanding anything to the contrary in subclause (1) of this regulation, the grants payable under paragraph (b) of subclause (1) of regulation 2 of the principal regulations for the period from the commencement of these regulations until the 31st day of January 1967 shall be at a rate necessary to reduce the grants payable for the whole year ending with that date to an amount equal to that which would have been payable if the grants prescribed under paragraph (b) of subclause (1) of regulation 2 of the principal regulations, as substituted by subclause (1) of this regulation, were payable for 10 months of the year, and the grants payable immediately before the commencement of these regulations under paragraph (b) of subclause (1) of regulation 2 of the principal regulations were payable for the remaining two months of the year.

3. Regulation 2 of the principal regulations is hereby further amended by revoking paragraph (g) of subclause (1), and substituting the

following paragraph:

"(g) A grant at the rate of £10 7s. 6d. for each student undertaking a course of training for primary teaching and at the rate of £12 for each student undertaking a course of training for secondary teaching who is on the roll of any teachers college in the district of the Board on the 1st day of March in the year of the grant but is not a student enrolled under a studentship providing for full-time university study as part of his course of teacher training, which grant shall be applied as follows:

> (i) Two pounds ten shillings of the grant for each student shall be expended upon books for the library of the teachers

college:

"(ii) The balance shall be expended upon the teaching of swimming, class materials and equipment, expenses of museum classes, physical education, and other incidental expenses, the cost of office expenses (excluding office salaries) at the teachers college, and the medical examination of applicants for admission to the teachers college:".

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for increases of the amounts of the capitation grants to Education Boards for the incidental expenses of State primary schools and teachers colleges.
