**THE EDUCATION BOARD GRANTS REGULATIONS 1965,
AMENDMENT NO. 3**

ORDER IN COUNCIL

At the Government House at Wellington this 16th day of August 1967

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Education Board Grants Regulations 1965, Amendment No. 3, and shall be read together with and deemed part of the Education Board Grants Regulations 1965* (hereinafter referred to as the principal regulations).

2. Regulation 2 of the principal regulations is hereby amended by revoking subparagraph (i) of paragraph (a) of subclause (1), and substituting the following subparagraph:

“(i) An amount determined in accordance with the following scale:

Number of Pupils on the Rolls of State Primary Schools under the Control of the Education Board Ascertained in Accordance With These Regulations (Including Pupils on the Rolls of Intermediate Schools and Intermediate Departments Attached to District High Schools, and on the Rolls of Secondary Departments of District High Schools)	Amount for Each Complete 100 and the Balance (if Any) in Excess of Every Complete 100 of the Pupils
For the first 10,000 pupils	\$ 360 280”
For all pupils in excess of 10,000

3. Regulation 2 of the principal regulations is hereby further amended by revoking paragraph (g) of subclause (1), as substituted by regulation 3 of the Education Board Grants Regulations 1965, Amendment No. 1, and substituting the following paragraph:

“(g) A grant at the rate of \$21.75 for each student undertaking a course of training for primary teaching and at the rate of \$25 for each student undertaking a course of training for secondary teaching who is on the roll of any teachers college in the district of the Board on the 1st day of March in the year of the grant but is not a student enrolled under a studentship providing for full-time university study as part of his course of teacher training, which grant shall be applied as follows:

“(i) Six dollars of the grant for each student shall be expended upon books for the library of the teachers college:

“(ii) The balance shall be expended upon the teaching of swimming, class materials and equipment, physical education, and other incidental expenses, the cost of office expenses (excluding office salaries) at the teachers college, and the medical examination of applicants for admission to the teachers college:”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the grant to Education Boards for general purposes, and the capitation grant to Education Boards in respect of students undertaking courses of training at teachers colleges. They also increase the proportion of the capitation grant to be expended on books for the libraries of teachers colleges.
