THE EDUCATIONAL BURSARIES REGULATIONS 1940, AMENDMENT NO. 6

ORDER IN COUNCIL

At the Government House at Wellington, this 24th day of October 1951

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Educational Bursaries Regulations 1940, Amendment No. 6, and shall be read together with and deemed part of the Educational Bursaries Regulations 1940* (hereinafter referred to as the principal regulations).

2. (1) Regulation 13 of the principal regulations is hereby amended by adding to subclause (1) the following paragraph :—

"(f) If the Professorial Board of the College at which the holder is enrolled reports to the Director that in its opinion the holder's work for any year has been so unsatisfactory as to warrant the forfeiture of the bursary."

(2) Regulation 13 of the principal regulations is hereby further amended by adding the following subclause :---

"(4) A student whose bursary has been forfeited in accordance with paragraph (f) of subclause (1) of this regulation may have such part of his bursary reinstated as the Director thinks fit if the Professorial Board of his college certifies that his work over a period of at least one year after the bursary has been forfeited has so improved as to justify the reinstatement of part of the bursary."

3. (1) Regulation 20 of the principal regulations is hereby amended, as from the 31st day of December 1951, by revoking the proviso to subclause (3), as set out in regulation 2 of the Educational Bursaries Regulations 1940, Amendment No. 2, and substituting the following proviso :—

"Provided that a candidate for a National Boarding Bursary may select subjects for examination for which the maximum number of marks obtainable, in accordance with the Scholarship Regulations,

is not less than 800 or more than 1,000; and the marks allotted to the candidate by the examiner shall be adjusted, in such manner as the Director thinks proper, as if the maximum number of marks obtainable for all the subjects by the candidate were 1,000."

(2) Regulation 2 of the Educational Bursaries Regulations 1940, Amendment No. 2, is hereby revoked as from the 31st day of December 1951.

4. Regulation 31 of the principal regulations, as inserted by regulation 11 of the Education Amending Regulations 1946, is hereby amended—

- (a) By omitting from subclause (2) the words "the commencement of the third term", and substituting the words "the termination of the second term"; and
- (b) By omitting from the proviso to subclause (3) the words "than the 22nd day of October in any year", and substituting the words "in any year than the Friday immediately following the date fixed by regulations for the time being in force for the commencement of the third term in public postprimary schools".

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations relate to the forfeiture and reinstatement of Educational Bursaries, the marks for the subjects for the National Boarding Bursaries Examination, and the closing date for applications to enter for the Special Bursaries Examinations.
