## THE EDUCATIONAL BURSARIES REGULATIONS 1940, AMENDMENT NO. 7

# FREYBERG, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington, this 16th day of June 1952

#### Present:

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. These regulations may be cited as the Educational Bursaries Regulations 1940, Amendment No. 7, and shall be read together with and deemed part of the Educational Bursaries Regulations 1940\* (hereinafter referred to as the principal regulations).

**2.** Regulation 26 of the principal regulations, as amended by regulation 7 of the Education Amending Regulations 1946†, is hereby further amended by omitting from subclause (1) the words "drawing in

the School Certificate Examination and in".

**3.** Regulation 31 of the principal regulations (as inserted by regulation 11 of the Education Amending Regulations 1946† and amended by regulation 27 of the Education Amending Regulations 1950‡) is hereby further amended by revoking subclauses (4) to (8), and substituting the following subclauses:—

"(4) The subjects of the examination shall be such of the subjects of the Entrance Examination of the University of New Zealand as are from time to time notified by the Director in the *Education Gazette*. The Director, in any such notification, may specify that any subject so notified may not be taken with any other subject, and may also specify

the number of subjects for which candidates are required to sit, and may require a candidate who enters for examination in a science subject to submit before the date of examination a certificate from the Principal of the school attended that a course of practical instruction based on the prescription has been satisfactorily completed.

"(5) The prescriptions of the subjects of the examination shall be the same as the prescriptions of those subjects for the Entrance Examina-

tion of the University of New Zealand."

**4.** Regulation 27 of the Education Amending Regulations 1950\* is hereby revoked.

#### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations provide that the subjects of the special examination for educational bursaries are to be selected by the Director of Education from the subjects of the Entrance Examination of the University of New Zealand and notified in the Education Gazette. The prescriptions of the subjects for the special examination are to be the same as the prescriptions of those subjects for the Entrance Examination of the University of New Zealand. The stipulation, in connection with bursaries in architecture, that preference is to be given to candidates who have shown special proficiency in drawing in the School Certificate Examination is not to apply in future.
