

THE EDUCATIONAL BURSARIES REGULATIONS 1940. AMENDMENT NO. 8

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Educational Bursaries Regulations 1940, Amendment No. 8, and shall be read together with and deemed part of the Educational Bursaries Regulations 1940* (hereinafter referred to as the principal regulations).
- **2.** Subclause (1) of regulation 6 of the principal regulations is hereby amended-
 - (a) By adding to paragraph (c) the word "or":

 - (b) By adding the following paragraph:

 "(d) Who is admitted to New Zealand on a study permit by the Department of Labour and who under the permit is required to leave New Zealand after the completion of his studies."
- 3. Subclause (2) of regulation 6 of the principal regulations, as added by regulation 3 of the Educational Bursaries Regulations 1940, Amendment No. 1, is hereby amended by inserting, after the words "or paragraph (b)", the words "or paragraph (d)".
- 4. Regulation 19 of the principal regulations is hereby amended by inserting, after the word "satisfied", the words "that the person's home or usual place of residence at the time of his making his application is in New Zealand, and".

5. Subclause (5) of regulation 22 of the principal regulations, as added by regulation 5 of the Education Amending Regulations 1946, is hereby amended by inserting, after the word "satisfied", the words "that the holder's home or usual place of residence at the time of his making his application for the payment of boarding allowance is in New Zealand, and ".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations impose restrictions upon the granting of a bursary to a student from overseas who is admitted to New Zealand on a study permit, and forbid the granting of a National Boarding Bursary or of a boarding allowance to the holder of a Special Bursary unless the applicant's home or usual place of residence at the time of his making his application is in New Zealand.
