## THE EDUCATIONAL BURSARIES REGULATIONS 1957. AMENDMENT NO. 1

# COBHAM, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 27th day of August 1958

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. These regulations may be cited as the Educational Bursaries Regulations 1957, Amendment No. 1, and shall be read together with and deemed part of the Educational Bursaries Regulations 1957\* (hereinafter referred to as the principal regulations).

2. Subclause (3) of regulation 5 of the principal regulations is hereby amended by adding the words "or a scholarship awarded from the funds of the Taranaki Scholarships Trust Board".

3. Subclause (2) of regulation 17 of the principal regulations is

hereby amended by adding the following proviso:

"Provided that the maximum period of any such bursary may be reduced by a period not exceeding the period (if any) during which the holder has previously held any other scholarship, bursary, or allowance, by whatever name called, awarded or made from public funds, including the funds of the Taranaki Scholarships Trust Board, for the purpose of assisting his studies at any college, or has held a University Entrance Scholarship."

4. The principal regulations are hereby amended by inserting, after

regulation 32, the following regulation:

"32A. Notwithstanding anything to the contrary in this Part of these regulations, the Director may award a Higher School Certificate Parttime Bursary, or a Higher School Certificate Full-time Bursary, or a Higher School Certificate Boarding Bursary, as appropriate, to a person who has been prevented from qualifying for the award of a Higher School Certificate or a Higher School Certificate in Fine Arts, as the case may be, by reason of the fact that it has been necessary for him

to reside outside New Zealand during the time that his parents, though normally resident in New Zealand, have as part of the duties connected with their livelihood been required to reside temporarily outside New Zealand:

"Provided that the Director shall be satisfied that the candidate for a bursary under this regulation has attended an appropriate educational institution for an appropriate time and has reached a standard of attainment not lower than that which would have enabled him to qualify for the award of a Higher School Certificate."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.
