AMENDMENT NO. 6**

ORDER IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title—These regulations may be cited as the Education (Assessment, Classification, and Appointment) Regulations 1965, Amendment No. 6, and shall be read together with and deemed part of the Education (Assessment, Classification, and Appointment) Regulations 1965* (hereinafter referred to as the principal regulations).

2. Interpretation—Regulation 2 of the principal regulations is hereby amended by revoking the definition of the expression “confidential notes”.

3. General assessments by District Boards of Inspectors—(1) Regulation 7 of the principal regulations is hereby amended by inserting in subclause (1), after the words “apply, and”, the words “, in the case of an applicant for a report for Division B, Division C, or Division D,”.

(2) The said regulation 7 is hereby further amended by revoking paragraph (c) of subclause (1) (as substituted by regulation 2 of the Education (Assessment, Classification, and Appointment) Regulations 1965, Amendment No. 1), and substituting the following paragraph:

“(c) He will, in the case of an application for a report for a higher division than the division he occupies, have completed the qualifying service for a report for the higher division not later than the 31st day of October of the year immediately following that in which he makes his application.”

4. Personal reports for probationary assistants becoming certificated primary teachers—The principal regulations are hereby further amended by revoking regulation 11.

5. Personal reports and confidential notes—Regulation 12 of the principal regulations is hereby amended by omitting the words “and confidential notes”.

6. Confidential notes—The principal regulations are hereby further amended by revoking regulation 13.

7. Qualification for personal reports—The principal regulations are hereby further amended by omitting from regulation 14 the words “for a higher division”.

8. Reports without completion of qualifying service—(1) Regulation 15 of the principal regulations is hereby amended by inserting in subclause (1), after the words “for a higher division”, the words “than the division he occupies”.

(2) The said regulation 15 is hereby further amended by inserting in subclause (2), after the words “for a higher division”, the words “than the division he occupies”.

9. Scales of general assessments—Regulation 16 of the principal regulations is hereby amended by omitting the words “For Division A personal reports—1 to 9, 9 being the highest:”.

10. Highest general assessment—Regulation 17 of the principal regulations is hereby amended by omitting the words “For Division A—3:”.

11. Procedure of appeals—Regulation 70 of the principal regulations is hereby amended by revoking paragraph (c) of subclause (1), and substituting the following paragraph:

“(c) At the hearing of an appeal against a primary assessment, the evidence given by any Inspector shall be confined to an elaboration of the data in the teacher’s personal report; and neither the appellant nor any Inspector may cite the personal reports of other teachers:”.

12. Revocation—The Education (Assessment, Classification, and Appointment) Regulations 1965, Amendment No. 1, are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Education (Assessment, Classification, and Appointment) Regulations 1965. The giving of personal reports on Division A primary teachers is discontinued. The giving of confidential notes is discontinued.
