THE EDUCATION (SCHOOL COMMITTEES INCIDENTAL EXPENSES) REGULATIONS 1949

THE RIGHT HON. W. NASH PRESIDING IN COUNCIL

Pursuant to the Education Act, 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Education (School Committees Incidental Expenses) Regulations 1949.
 - 2. In these regulations unless the context otherwise requires—

"The Act" means the Education Act, 1914:

- "Board" means the Education Board of any education district established under the Act:
- "School" means any school established under Part V of the Act and subject to the control of a Board, and includes a district high school, an intermediate school, and an intermediate department in respect of which a School Committee exercises jurisdiction:
- "Minister" means the Minister of Education.
- **3.** For the purposes of paragraph (b) of section 36 of the Act, incidental expenses shall include expenses for all or any of the following purposes:—
 - (a) The payment of wages of caretakers and cleaners employed in or about school premises:
 - (b) The payment of costs, charges, or expenses (excluding the payment of wages of caretakers and cleaners) connected with—
 - (i) The cleaning and heating of school premises;
 - (ii) The supply of water for all purposes to school premises;
 - (iii) The provision of adequate sanitary services for

school premises;

(iv) The repair, maintenance, and improvement of school grounds and equipment and the minor repair of school buildings, including the installation of power-points, the replacement of electric lamps and shades, the repair of locks,

window-fasteners, window-cords, gate hinges and latches, the renovation of fences, and the cleaning of guttering and spouting;

(v) The provision and maintenance of school libraries;

(vi) The supply of equipment (excluding equipment for organized school games) for physical education.

(vii) The supply, storage, and distribution of milk for

pupils in schools;

(viii) The supply of stationery, apparatus, and material for handwork, infant-room equipment, first-aid equipment, a New Zealand Ensign, sewing-machines, duplicators, and typewriters, and other school requisites;

(ix) The supply of school pictures, projectors, film strips,

and other visual aids to education;

- (x) The supply of stationery for the purposes of School Committees and the postage of mail used in the transaction of the business of School Committees;
- (xi) The rental of any telephone installed in school premises but not exceeding half of any such rental and not including the rental of a telephone installed in the living quarters of a teacher;
- (xii) The payment of insurance premiums in respect of the insurance of property purchased by School Committees or in respect of insurance against any other liability to which a Committee may be subject;
- (xiii) The purchase of equipment for the supply, preparation, and distribution of hot meals for pupils in schools and the purchase of such ingredients for any such meals as the Board may approve.
- 4. All the amounts paid to a Board in respect of incidental expenses shall be distributed by it amongst the School Committees in its education district in such proportions as the Board considers necessary, and when making any such distribution the Board shall indicate to the Committee concerned the purpose or purposes for which the funds so distributed are to be expended.
- 5. Each School Committee shall apply all moneys received by it for the payment of wages of caretakers and cleaners for that purpose and no other. If at the end of any year a balance of the sum paid to a Committee for that purpose remains in the hands of the Committee, the Committee shall, as the Board decides, either repay the balance to the Board or apply the balance for the same purpose during the next ensuing year.
- **6.** Caretakers and cleaners employed in or about any school shall be employed only on such terms and conditions as the Minister shall from time to time direct.
- 7. A Board may by its by-laws require that a School Committee apply any grant received by it from the Board for the purposes of paying the incidental expenses specified in paragraph (b) of Regulation 3 hereof to the payment of any one or more of those incidental expenses and in such order of priority as the Board thinks fit.
- 8. The regulations specified in the Schedule hereto are hereby revoked to the extent indicated therein.
