**EXEMPTING CERTAIN PATRIOTIC PURPOSES FROM THE  
PATRIOTIC PURPOSES EMERGENCY REGULATIONS 1939.**

Office of the Minister of Internal Affairs,  
Wellington, 4th October, 1939.

PURSUANT to clause (5) of Regulation 3 of the Patriotic Purposes Emergency Regulations 1939,\* I, William Edward Parry, Minister of Internal Affairs, do hereby exempt from the application of the said regulations :—

1. The carrying-on of the spiritual work and ministrations of any religious denomination amongst members of the armed Forces by the authorized Ministers and officers of that denomination so far as funds for such purpose are raised by collection made and sought exclusively from the members and adherents of that denomination.

2. A presentation to any person on his proceeding to or returning from service with any of His Majesty's Naval, Military, or Air Forces so far as funds for such purpose are raised by collection made and sought exclusively from members of a society, association, club, institution, or other body of persons of which such person is a member, or the principals and employees of an undertaking in which such person is employed or is a principal.

3. The raising of funds by and with the authority of the Mayor of a borough or the Chairman of a local authority for the purpose of making gifts to residents within the borough or the district of such local authority or of any part thereof who are proceeding to or returning from such service as aforesaid.

4. The holding of any function or entertainment in honour of any member or members of the Forces arranged by any person or body of persons approved for the purpose thereof, or of a series of such functions or entertainments extending over a period of not more than six months at any one time, by the Chairman of the Provincial Council or of the Controlling Committee of the subdivision of the Provincial District within which such function, entertainment, or series is to be held :

Provided that—

(a) The person or body promoting such function or entertainment or series shall not appeal for or in any other way solicit moneys in aid thereof or advertise or in any other way hold out the same as being in aid of any patriotic purpose ; but nothing herein shall operate to prohibit the making for admission thereto of such charge as is approved by the Chairman of the Provincial Council or Controlling Committee ;

- (b) A detailed statement of receipts and payments in respect of each such function or entertainment is furnished to the Provincial Council or Controlling Committee within seven days after the holding thereof ;
- (c) Any balance of receipts over payments in respect of any such function or entertainment or of any such series shall be disposed of in such manner for such approved patriotic purpose or purposes as the Provincial Council or Controlling Committee directs ;
- (d) At such time or times as the Minister directs, such particulars of such function, entertainment, or series as the Minister requires shall be forwarded to him by the Provincial Council or Controlling Committee ;
- (e) Approval granted in respect of any such function, entertainment, or series may at any time be revoked by the person granting the same, or by the Minister.
