PURSUANT to the Reserve Bank of New Zealand Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Exchange Control Regulations 1985, Amendment No. 13, and shall be read together with and deemed part of the Exchange Control Regulations 1985* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1987.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 October 1987, delete the name National Australia Limited from the list of authorised foreign exchange dealers that is set out in the First Schedule to the Exchange Control Regulations 1985 and substitute the name National Australia Bank (NZ) Limited in consequence of the transfer of the foreign exchange business of that company to National Australia Bank (NZ) Ltd.

The regulations delete the name Wardley New Zealand Limited and substitute the name The Hongkong and Shanghai Banking Corporation in consequence of the transfer of the foreign exchange business of that company to The Hongkong and Shanghai Banking Corporation.
