PURSUANT to the Reserve Bank of New Zealand Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Exchange Control Regulations 1985, Amendment No. 14, and shall be read together with and deemed part of the Exchange Control Regulations 1985* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. First Schedule amended—The First Schedule to the principal regulations (as substituted by the Exchange Control Regulations 1985, Amendment No. 13) is hereby amended—

- (a) By inserting, after the name “ANZ Banking Group (New Zealand) Limited”, the name “Bancorp Securities Limited”;
- (b) By inserting, after the name “Bank of New Zealand,” the name “Banque Indosuez New Zealand Limited”;
- (c) By omitting the name “Indosuez New Zealand Limited”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the day after the date of their notification in the *Gazette*, add the name Bancorp Securities Limited to the list of authorised foreign exchange dealers that is set out in the First Schedule to the Exchange Control Regulations 1985. They also delete the name Indosuez New Zealand Limited and substitute the name Banque Indosuez New Zealand Limited in consequence of the change of name of that company.
