## ORDER IN COUNCIL

PURSUANT to the Reserve Bank of New Zealand Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Exchange Control Regulations 1985, Amendment No. 4, and shall be read together with and deemed part of the Exchange Control Regulations 1985\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- **2. New First Schedule substituted**—The principal regulations are hereby amended by revoking the First Schedule, and substituting the First Schedule set out in the First Schedule to these regulations.

# Exchange Control Regulations 1985, Amendment No. 4

## **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations add the name National Australia Limited to the list of authorised foreign exchange dealers that is set out in the First Schedule to the Exchange Control Regulations 1985.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 6 March 1986.

These regulations are administered in the Reserve Bank of New Zealand.
