

## THE EXCISE DUTY (ALCOHOLIC BEVERAGES INDEXATION) AMENDMENT ORDER 1990

#### ORDER IN COUNCIL

At Wellington this 30th day of April 1990

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL PURSUANT to section 118cB of the Customs Act 1966, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Excise Duty (Alcoholic Beverages Indexation) Amendment Order 1990.

  (2) This order shall come into force on the 1st day of June 1990.
- 2. #### EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into effect on 1 June 1990, reflects changes in the Excise Duties adjusted according to the Consumer Price Index based on its movement over the previous two quarters.
