PURSUANT to section 58 of the Boilers, Lifts, and Cranes Act 1950, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Engine Drivers' Examination Regulations 1952, Amendment No. 14, and shall be read together with and deemed part of the Engine Drivers' Examination Regulations 1952* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.

2. Interpretation—(1) Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "Department".

(2) Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "Secretary", and substituting the following definition:

"'Prescribed fee', in relation to any matter connected with any examination conducted under these regulations, means the fee (if any) prescribed in respect of that matter under Part XV of the Education Act 1989 by the body that governs the institution conducting the examination under section 40 of the Act:".

3. First-class engine drivers' examination—Regulation 11B (e) of the principal regulations (as substituted by regulation 2 (1) of the Engine Drivers' Examination Regulations 1952, Amendment No. 7) is hereby amended by omitting the words "all the subjects of Division B", and substituting the words "only that subject".

4. Refund of fees—Regulation 15 of the principal regulations is hereby amended by omitting the words "No refund shall be made except upon the recommendation of the Board and with the approval of the Secretary."

5. Medical certificates—Regulation 20 of the principal regulations is hereby amended by revoking subclause (2), and substituting the following subclause:

"(2) Any such certificate shall be dated not more than 12 months prior to the date upon which the application reaches the institution conducting the examination concerned."

6. Failure in examination—Regulation 22 of the principal regulations is hereby amended—

- (a) By omitting from subclause (1) the words "(other than the extra first class stationary engineers' examination)":

7. Revocations—The following regulations are hereby revoked:

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after the date of their notification in the *Gazette*, amend the Engine Drivers' Examination Regulations 1952. The regulations facilitate the transfer of the administration of the examinations under the principal regulations from the Ministry of Transport to tertiary education institutions and revoke obsolete provisions.
