

# THE ENGINE DRIVERS' EXAMINATION REGULATIONS 1952, AMENDMENT NO. 2

# C. W. M. NORRIE, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 15th day of December 1954

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Boilers, Lifts, and Cranes Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. (1) These regulations may be cited as the Engine Drivers' Examination Regulations 1952, Amendment No. 2, and shall be read together with and deemed part of the Engine Drivers' Examination Regulations 1952\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- 2. (1) Regulation 12 of the principal regulations is hereby amended by revoking subclause (1), and substituting the following subclause:
- "(1) Examinations shall be held at the offices of the Marine Department as follows:
  - "(a) At Hamilton, Tauranga, Napier, New Plymouth, Wanganui, Palmerston North, Wellington, Greymouth, Christchurch, Dunedin and Invercargill—on the first working day (except Saturday) of February, May, August, and November in each year:
  - "(b) At Auckland—on the first working day (except Saturday) after the 14th day of February, May, August, and November in each year:
  - "(c) At Nelson—on the first working day (except Saturday and Anniversary Day) of February, May, August, and November in each year:
  - "(d) At Timaru—on the first Tuesday after the 14th day of May and the first Tuesday after the 14th day of October in each year:

"(e) At the following places on the first working day in each year after the dates specified:

"(i) At Gisborne—the 14th day of February and the

14th day of August:

"(ii) At Whangarei—the 14th day of January and the 14th day of June."

- (2) Regulation 2 of the Engine Drivers' Examination Regulations 1952, Amendment No. 1, is hereby revoked.
- 3. The form of application for an engine driver's certificate in the Schedule to the principal regulations, as amended by regulation 5 of the Engine Drivers' Examination Regulations 1952, Amendment No. 1, is hereby further amended as follows:

(a) By inserting in paragraph (a) of clause (1) of the Instructions to candidates, after the word "Hamilton", the word

"Tauranga":

- (b) By omitting from the said paragraph (a) the words "at the following places on the first working day (except Saturday): At Gisborne after 14th February and 14th August; at Timaru after 14th May and 14th October; at Whangarei after 14th January and 14th June", and substituting the words "at Timaru on the first Tuesday after the 14th May and first Tuesday after 14th October; and at the following places on the first working day (except Saturday): At Gisborne after 14th February and 14th August; at Whangarei after 14th January and 14th June".
- 4. Regulation 5 of the Engine Drivers' Examination Regulations 1952, Amendment No. 1, is hereby revoked.

### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

Regulation 2 replaces the previous provision prescribing dates and places for examinations and includes Tauranga as a place for examination. An alteration is also made in respect of the dates for examinations in Timaru.

Regulation 3 makes consequential alterations to the form of application for an engine drivers' certificate.
