PURSUANT to section 118CB of the Customs Act 1966, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### **ORDER**

- 1. Title and commencement—(1) This order may be cited as the Excise Duty (Tobacco Products Indexation) Amendment Order 1992.
  - (2) This order shall come into force on the 1st day of June 1992.
- 2. Third Schedule—The Third Schedule to the Customs Act 1966 is hereby amended by revoking so much as relates to Excise item numbers 99.60.10E, 99.60.25C, 99.60.35L, 99.65.10G, 99.65.20D, 99.65.30A, 99.65.40J, 99.65.45K, and 99.65.60C, and substituting the Excise item numbers and rates of duty specified in the Schedule to this order.
- **3. Consequential revocation**—The Excise Duty (Tobacco Products Indexation) Amendment Order (No. 2) 1991 (S.R. 1991/233) is hereby revoked.

This order, which comes into effect on 1 June 1992, adjusts the excise duties on tobacco products to reflect the movement in the Consumers Price Index over the 2 quarters ending 31 December 1991 and 31 March 1992.
