ORDER IN COUNCIL

PURSUANT to section 118CB of the Customs Act 1966, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Excise Duty (Tobacco Products Indexation) Amendment Order (No. 2) 1990.

(2) This order shall come into force on the 1st day of September 1990.

2. Third Schedule—The Third Schedule to the Customs Act 1966 is hereby amended by revoking so much as relates to Excise item numbers 99.60.10E, 99.60.25C, 99.60.35L, 99.65.10G, 99.65.20D, 99.65.30A, 99.65.40J, 99.65.45K, and 99.65.60C, and substituting the Excise item numbers and rates of duty specified in the Schedule to this order.

3. Consequential revocations—The Excise Duty (Tobacco Products Indexation) Amendment Order 1990 (S.R. 1990/20) is hereby amended by revoking so much of the Schedule to that order as relates to Excise item numbers 99.60.10E, 99.60.25C, 99.60.35L, 99.65.10G, 99.65.20D, 99.65.30A, 99.65.40J, 99.65.45K, and 99.65.60C.
