

# THE EXCISE DUTY (TOBACCO PRODUCTS INDEXATION) AMENDMENT ORDER (NO. 2) 1992

### ORDER IN COUNCIL

#### Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 118CB of the Customs Act 1966, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### ORDER

- 1. Title and commencement—(1) This order may be cited as the Excise Duty (Tobacco Products Indexation) Amendment Order (No. 2) 1992.
  - (2) This order shall come into force on the 1st day of December 1992.
- 2. Third Schedule—The Third Schedule to the Customs Act 1966 is hereby amended by revoking so much as relates to Excise item numbers 99.60.10E, 99.60.25C, 99.60.35L, 99.65.10G, 99.65.20D, 99.65.30A, 99.65.40J, 99.65.45K, and 99.65.60C, and substituting the Excise item numbers and rates of duty specified in the Schedule to this order.
- **3. Consequential revocation**—The Excise Duty (Tobacco Products Indexation) Amendment Order 1992 (S.R. 1992/83) is hereby revoked.

#### EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 December 1992, adjusts the excise duties on tobacco products to reflect the movement in the Consumers Price Index over the 2 quarters ending 30 June 1992 and 30 September 1992.
