PURSUANT to section 118c of the Customs Act 1966, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Excise Duty (Tobacco Substitutes) Amendment Order 1994.

(2) This order shall come into force on the 1st day of July 1994.

2. Third Schedule amended—The Third Schedule to the Customs Act 1966 is hereby amended by revoking so much as relates to Excise item numbers 99.60.10E, 99.60.25c and 99.60.35L and substituting the Excise item numbers and rates of duty specified in the Schedule to this order.

3. Consequential revocation—The Excise Duty (Tobacco Products Indexation) Amendment Order 1994 (S.R. 1994/72) is hereby amended by revoking so much of the Schedule as relates to Excise item numbers 99.60.10E, 99.60.25c, and 99.60.35L.
