**THE EDUCATION (UNAUTHORISED EXPENDITURE)
REGULATIONS 1972**

ORDER IN COUNCIL

At the Government House at Wellington this 18th day of December 1972

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title—These regulations may be cited as the Education (Unauthorised Expenditure) Regulations 1972.

2. Maximum amount of unauthorised expenditure of education boards—(1) The education boards named in the Schedule to these regulations may, in any year ending with the 31st day of January, expend in accordance with section 37 of the Education Act 1964 any sum or sums not amounting in the whole to more than 1 percent of such portion of their income for that year as is payable to their general funds, nor in the case of each education board named in the said Schedule, amounting in the whole to more than the amount specified in the said Schedule in respect of the education board.

(2) Notwithstanding anything in subclause (1) of this regulation, any education board may spend during any year in which it celebrates its centenary a further amount out of its general fund not exceeding \$1,000 in total. It shall be a condition to be complied with by each board spending any of this amount that the board shall spend it on displays, exhibitions, or projects, of an educational nature and to which members of the public are admitted, for the purposes of celebrating the centenary of the board.

3. Unauthorised expenditure of governing bodies of secondary schools—Out of its income received for general or incidental purposes, the governing body of any secondary school may, in any year ending with the 31st day of January, expend in accordance with section 67 of the Education Act 1964 any sum or sums not amounting in the whole to more than 1 percent of such portion of its income for that year as is chargeable with general or incidental expenses, nor in any case amounting in the whole to more than \$200 for each school controlled by it.

4. Unauthorised expenditure of the board of governors of technical institutes—Out of its income received for general or incidental purposes, the board of governors of any technical institute may, in any year ending with the 31st day of January, expend in accordance with sections 67 and 69 (7) of the Education Act 1964 any sum or sums not amounting in the whole to more than 1 percent of such portion of its income for that year as is chargeable with general or incidental expenses, nor in any case amounting in the whole to more than \$400 for each technical institute controlled by it.

5. Unauthorised expenditure of teachers college councils—Out of its income received for general or incidental purposes, any teachers college council may, in any year ending with the 31st day of January, expend in accordance with sections 67 and 106 (3) of the Education Act 1964 any sum or sums not amounting in the whole to more than 1 percent of such portion of its income for that year as is chargeable with general or incidental expenses, nor in any case amounting in the whole to more than \$400 for each teachers college controlled by it.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe the maximum amounts that may be spent by way of unauthorised expenditure by education boards, governing bodies of secondary schools, governing bodies of technical institutes, and teachers college councils.
