PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Education (Unauthorised Expenditure) Regulations 1985.

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. Interpretation—In these regulations, “the Act” means the Education Act 1964.

3. Maximum annual unauthorised expenditure of Education Boards—(1) There is hereby prescribed for the purposes of section 37 (1) of the Act, in respect of the Education Board of each District specified in the Schedule to these regulations, the amount specified opposite the reference to that District in that Schedule.

(2) There is hereby prescribed for the purposes of section 37 (2) of the Act a further amount not exceeding \$1,800; but no amount shall be spent pursuant to that subsection unless it is spent—

- (a) For the purpose of celebrating the centenary of the Education Board concerned; and
- (b) On displays, exhibitions, or projects, of an educational nature, to which members of the public are admitted.

4. Maximum annual unauthorised expenditure of governing bodies of secondary schools—There is hereby prescribed for the purposes of section 67 of the Act (so far as it applies to the governing bodies of secondary schools) an amount in respect of each such governing body not exceeding \$600 for each school controlled by it.

5. Maximum annual unauthorised expenditure of boards of governors of technical institutes—There is hereby prescribed for the purposes of section 67 of the Act (so far as it applies to the boards of governors of technical institutes) an amount in respect of each such board not exceeding \$1,300 for each technical institute controlled by it.

6. Maximum annual unauthorised expenditure of boards of governors of community colleges—There is hereby prescribed for the purposes of section 67 of the Act (so far as it applies to the boards of governors of community colleges) an amount in respect of each board not exceeding \$1,300 for each community college controlled by it.

7. Maximum annual unauthorised expenditure of teachers college councils—There is hereby prescribed for the purposes of section 67Q of the Act an amount in respect of each teachers college council not exceeding \$1,300 for each teachers college controlled by it.

8. Revocation—The Education (Unauthorised Expenditure) Regulations 1982* are hereby consequentially revoked.

 EXPLANATORY NOTE

This not is not part of the regulations but is intended to indicate their general effect.

These regulations replace, with amendments, the Education (Unauthorised Expenditure) Regulations 1982.

The amendments increase the maximum amounts that Education Boards, the governing bodies of secondary schools, boards of governors of technical institutes and community colleges, and teachers college councils may expend annually for purposes that are otherwise unauthorised, and set a maximum amount for boards of governors of community colleges. In the case of Education Boards amounts are increased from \$2,000 to \$2,400 for the Auckland, Hamilton, Wellington, and Canterbury Education Boards, and from \$1,500 to \$1,800 for all other Education Boards. The amount for the governing bodies of secondary schools is increased from \$500 to \$600 per school; and the amounts for boards of governors of technical institutes and community colleges, and teachers college councils, are increased from \$1,100 to \$1,300 per institute, college, or council.
