

THE EDUCATION (TRUSTEE ELECTIONS) REGULATIONS 1992, AMENDMENT NO. 1

PURSUANT to section 118 of the Education Act 1989, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Education (Trustee Elections) Regulations 1992, Amendment No. 1, and shall be read together with and deemed part of the Education (Trustee Elections) Regulations 1992* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.
- **2. Inspection of rolls**—Regulation 6 of the principal regulations is hereby amended by inserting, after the word "inspection", the words "at any reasonable time".

3. Inspection of nominations—The principal regulations are hereby amended by inserting, after regulation 13, the following regulation:

"13a. Every—

"(a) Nomination; and

- "(b) Separate consent under regulation 12 (1) of these regulations,— received before nominations close shall be open to inspection at any reasonable time, in the hands of the returning officer, by any person whose name is on the roll."
- **4. Counting of votes**—(1) Regulation 20 of the principal regulations is hereby amended by omitting the expression "9th", in both places where it occurs, and substituting in each case the expression "6th".
- (2) Regulation 17 (2) of and the voting form set out in Second Schedule to the principal regulations are hereby consequentially amended by omitting the expression "7 days", and substituting in each case the expression "5 days".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force 28 days after notification in the Gazette, make 3 amendments to the principal regulations.

First, counting of votes in elections is to take place—

- (a) In the case of boards of correspondence schools, boards of certain special institutions, and the parent representatives on the boards of other schools, on the 6th day after the election, rather than on the 9th day after the election as at present; and
- (b) In the case of student and staff representatives, before 6th day after the election, rather than before the 9th day after the election as at present.

Secondly, people whose names are on the roll are given a right to inspect nominations (in the hands of the returning officer) at any reasonable time.

Thirdly, the existing power to inspect the roll is modified so that inspection can take place only at reasonable times.
