PURSUANT to section 22 of the Territorial Sea and Exclusive Economic Zone Act 1977, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title, commencement, and application—(1) These regulations may be cited as the Exclusive Economic Zone (Licence Fees for Foreign Fishing Craft) Regulations 1978, Amendment No. 10, and shall be read together with and deemed part of the Exclusive Economic Zone (Licence Fees for Foreign Fishing Craft) Regulations 1978* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*, and shall apply in respect of every licence granted under section 15 of the Act to have effect on or after the 1st day

of April 1983.

Exclusive Economic Zone (Licence Fees for Foreign Fishing Craft) Regulations 1978, Amendment No. 10

2. Increase in foreign licence fees—The Schedule to the principal regulations (as substituted by regulation 2 of the Exclusive Economic Zone (Licence Fees for Foreign Fishing Craft) Regulations 1978, Amendment No. 9) is hereby amended by revoking items 3, 4, and 5, and substituting the following items:

"3. Licence to fish $\mathbf{b}\mathbf{v}$ trawling in Fisheries Management Area E

- "4. Licence to fish trawling in areas other than Fisheries Management Area E
- "5. Licence to fish by bottom-lining
- \$21 per tonne of fish that the craft is permitted by the conditions of its licence to take.
- \$35 per tonne of fish that the craft is permitted by the conditions of its licence to take.
- \$40 per tonne of fish that the craft is permitted by the conditions of its licence to take."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for an increase in the fees payable by foreign fishing craft for licences to fish in the exclusive economic zone for-

(a) Trawl caught finfish, from \$18 to \$21 per tonne of fish allocated in Area E:

(b) Trawl caught finfish, from \$28 to \$35 per tonne of fish allocated in areas other than

(c) Bottom longline caught finfish, from \$30 to \$40 per tonne.
