**THE EXPEDITIONARY FORCE EMERGENCY REGULATIONS
1940, AMENDMENT NO. 1.**

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 29th day of January, 1941.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Expeditionary Force Emergency Regulations 1940, Amendment No. 1.
2. These regulations shall be read together with and be deemed part of the Expeditionary Force Emergency Regulations 1940* (hereinafter referred to as the principal regulations).
3. Regulation 8 (ii) of the principal regulations is hereby amended by adding at the end thereof the words " and may return any members of the Expeditionary Force to New Zealand for duty."
4. There shall be a section of the Expeditionary Force to be known as the 8th Brigade Group, Second New Zealand Expeditionary Force (which section is hereinafter referred to as the 8th Brigade Group).
5. The composition of the 8th Brigade Group shall be as from time to time determined by the Army Board.
6. The powers of the General Officer Commanding under the principal regulations, as amended by these regulations, shall not be exercisable in respect of the 8th Brigade Group and shall not be exercisable in respect of any member of the Expeditionary Force who for the time being belongs to the 8th Brigade Group or to any unit forming part of the 8th Brigade Group.

7. The Governor-General may from time to time appoint an officer to command the 8th Brigade Group out of New Zealand, who shall be called the Officer Commanding the 8th Brigade Group, Second New Zealand Expeditionary Force. The Officer Commanding the 8th Brigade Group, Second New Zealand Expeditionary Force, shall have full power, subject only to the control and direction of the Army Board, to command, organize, and administer the 8th Brigade Group accordingly.

8. Subject to the control and direction of the Army Board, the Officer Commanding the 8th Brigade Group, Second New Zealand Expeditionary Force, may out of New Zealand exercise in respect of members of the Expeditionary Force who for the time being belong to the 8th Brigade Group, or to any unit forming part of the 8th Brigade Group, the same powers as the General Officer Commanding is authorized by Regulations 8, 9, and 10 of the principal regulations (as affected by these regulations) to exercise out of New Zealand in respect of other members of the Expeditionary Force.

9. In the case of members of the Expeditionary Force who for the time being are in New Zealand, the powers of transfer conferred by clause (2) of Regulation 17 of the National Service Emergency Regulations 1940* may be exercised by the Adjutant-General of the New Zealand Defence Forces.
