**THE EXPEDITIONARY FORCE EMERGENCY REGULATIONS  
1940, AMENDMENT NO. 2.**

**ORDER IN COUNCIL.**

At the Government House at Wellington, this 22nd day of  
October, 1941.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

**REGULATIONS.**

1. These regulations may be cited as the Expeditionary Force Emergency Regulations 1940, Amendment No. 2, and shall be read together with and deemed part of the Expeditionary Force Emergency Regulations 1940\* (hereinafter referred to as the principal regulations).

2. There shall be a section of the Expeditionary Force to be known as the United Kingdom Section, Second New Zealand Expeditionary Force (which section is hereinafter referred to as the United Kingdom Section).

3. The composition of the United Kingdom Section shall be as from time to time determined by the Army Board.

4. The powers of the General Officer Commanding under the principal regulations shall not be exercisable in respect of the United Kingdom Section and shall not be exercisable in respect of any member of the Expeditionary Force who for the time being belongs to the United Kingdom Section or to any unit forming part of the United Kingdom Section.

5. The Governor-General may from time to time appoint an officer to command the United Kingdom Section out of New Zealand, who shall be called the Officer Commanding the United Kingdom Section, Second New Zealand Expeditionary Force. The Officer Commanding the United Kingdom Section, Second New Zealand Expeditionary Force, shall have full power, subject only to the control and direction of the Army Board, to command, organize, and administer the United Kingdom Section accordingly.

6. Subject to the control and direction of the Army Board, the Officer Commanding the United Kingdom Section, Second New Zealand Expeditionary Force, may out of New Zealand exercise in respect of members of the Expeditionary Force who for the time being belong to the United Kingdom Section, or to any unit forming part of the United Kingdom Section, the same powers as the General Officer Commanding is authorized by Regulations 8, 9, and 10 of the principal regulations (as from time to time amended) to exercise out of New Zealand in respect of members of the Expeditionary Force who for the time being are under his command.

7. Regulation 8 of the Expeditionary Force Emergency Regulations 1940, Amendment No. 1, is hereby amended by omitting all words after the words "principal regulations", and substituting the words "(as from time to time amended) to exercise out of New Zealand in respect of members of the Expeditionary Force who for the time being are under his command".

8. Regulation 8 (i) of the principal regulations is hereby amended by inserting, after the word "appointments", the words "and promotions".

9. The Adjutant-General of the New Zealand Defence Forces or any officer or officers of the Defence Forces to whom the Adjutant-General may have delegated his powers in that behalf may, either within New Zealand or elsewhere, discharge warrant officers, non-commissioned officers, and men of the Expeditionary Force who for the time being are out of New Zealand.

10. The Adjutant-General of the New Zealand Defence Forces or any officer or officers of the Defence Forces to whom the Adjutant-General may have delegated his powers in that behalf may, either within New Zealand or elsewhere, transfer members of the Expeditionary Force from any section of the Expeditionary Force to any of the other sections thereof.
