## THE EDUCATION (POST-PRIMARY INSTRUCTION) REGULATIONS 1954, AMENDMENT NO. 3

#### ORDER IN COUNCIL

At the Government House at Wellington this 27th day of June 1962

Present:

#### HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. These regulations may be cited as the Education (Post-Primary Instruction) Regulations 1954, Amendment No. 3, and shall be read together with and deemed part of the Education (Post-primary Instruction) Regulations 1954\* (hereinafter referred to as the principal regulations).

2. Regulation 6 of the principal regulations is hereby amended by omitting from subclause (2) the words "the Monday immediately following the date fixed by regulations for the time being in force for the termination of the second term in public post-primary schools", and substituting the words "the 1st day of August".

**3.** Regulation 6 of the principal regulations is hereby further amended by adding to subclause (7) the following proviso:

"Provided that, where the Principal of the school attended by the candidate so recommends, a candidate may present himself for not more than five subjects in addition to English."

4. Regulation 6 of the principal regulations is hereby further amended by omitting from subclause (9) the words "14th day of February", and substituting the words "10th day of February".

5. The principal regulations are hereby amended by inserting, after regulation 7, the following heading and regulation:

### "The Certificate of Education

"7A. (1) The Certificate of Education shall be awarded to any person who has completed to the satisfaction of the Director a course of at least three years' work in accordance with the provisions of regulations 3

and 4 of these regulations and who, although not qualifying for the award of the School Certificate, has gained not less than 30 per cent of the total possible marks in any subject of the School Certificate Examination.

"(2) The Certificate of Education shall be in such form as the Director thinks fit, but every such certificate shall indicate on the face thereof the subject or subjects in respect of which it has been granted."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations vary the dates by which applications for entry for the School Certificate Examination and applications for the remarking of papers must be received. They increase the permissible number of subjects for the School Certificate Examination, and provide for the award of Certificates of Education.
