THE EDUCATION (POST-PRIMARY INSTRUCTION) **REGULATIONS 1954, AMENDMENT NO. 7**

Pursuant to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Education (Post-primary Instruction) Regulations 1954, Amendment No. 7, and shall be read together with and deemed part of the Education (Post-primary Instruction) Regulations 1954* (hereinafter referred to as the principal regula-
- 2. (1) The principal regulations are hereby amended by revoking regulation 9, (as substituted by regulation 2 of the Education (Postprimary Instruction) Regulations 1954, Amendment No. 1 and amended by regulation 2 of the Education (Post-primary Instruction) Regulations 1954, Amendment No. 4), and substituting the following regulation:

"9. The Higher School Certificate shall be granted to:

"(a) Any pupil who has satisfactorily completed, at a school to which these regulations apply, a five years' course of secondary instruction of not less than 100 units, if—

> "(i) He has been granted a School Certificate and thereafter has completed satisfactorily an advanced course of two years, including therein at least eight units in each of three

subjects approved by the Director-General; or

"(ii) He has obtained a qualification recognised by the Universities Entrance Board for admission to a university in New Zealand and has thereafter completed satisfactorily an advanced course of one year, including therein at least four units in each of three subjects approved by the Director-General:

"(b) Any pupil who has satisfactorily completed, at a school to which these regulations apply, a four years' course of secondary instruction of not less than 80 units, if—

"(i) He has obtained a credit pass or better in the Entrance Scholarship Examination conducted by the Universities

Entrance Board; or

"(ii) He has obtained a qualification recognised by the Universities Entrance Board for admission to a university in New Zealand and has also obtained an A or B pass in the Universities Bursaries Examination conducted by the Universities Entrance Board."

(2) Regulation 2 of the Education (Post-primary Instruction) Regulations 1954, Amendment No. 4, is hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations extend the class of cases in which a Higher School Certificate may be awarded by providing for the award of that certificate to persons who have obtained a qualification recognised by the Universities Entrance Board for admission to a university in New Zealand and have also obtained an A or B pass in the Universities Bursaries Regulations.
