### HIS EXCELLENCY THE GOVERNOR GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Education (Secondary Instruction) Regulations 1975, Amendment No. 14, and shall be read together with and deemed part of the Education (Secondary Instruction) Regulations 1975\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. New First Schedule substituted—(1) The principal regulations are hereby amended by revoking the First Schedule (as substituted by
