PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Education (Secondary Instruction) Regulations 1975, Amendment No. 8, and shall be read together with and deemed part of the Education (Secondary Instruction) Regulations 1975\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

**2. New First Schedule substituted**—(1) The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 3 (1) of the Education (Secondary Instruction) Regulations 1975, Amendment No. 7), and substituting the Schedule set out in the Schedule to these regulations.

(2) Regulation 3 of, and the Schedule to, the Education (Secondary Instruction) Regulations 1975, Amendment No. 7 are hereby consequentially revoked.

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations increase the School Certificate registration fee from \$5 to \$6, the examination fee per subject from \$5 to \$6, and the recount fee from \$5 to \$6; and abolish the maximum total examination fee.
