PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and Commencement—(1) These regulations may be cited as the Education (Secondary Instruction) Regulations 1975, Amendment No. 9, and shall be read together with and deemed part of the Education (Secondary Instruction) Regulations 1975* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the School Certificate registration fee from \$6 to \$7, the examination fee per subject from \$6 to \$7, the late fee from \$6 to \$7, the fee after the late entry closing date for an additional subject or change of subject from \$2 to \$2.50, and the recount fee from \$6 to \$7.
