#### THE EXPLOSIVES LICENSES EMERGENCY REGULATIONS 1942

## ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 15th day of July, 1942.

#### Present:

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL.

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS.

- 1. These regulations may be cited as the Explosives Licenses Emergency Regulations 1942.
- 2. (1) This regulation shall apply to the licenses hereinafter mentioned issued under the regulations made under the Explosive and Dangerous Goods Act, 1908, on the 27th day of July, 1914, and published in the Gazette on the 30th day of the same month\* (hereinafter in these regulations called the Explosives Regulations), that is to say:—
  - (a) Licenses to carry explosives:
  - (b) Licenses for lighters engaged in carrying explosives:
  - (c) Licenses to sell explosives and to keep explosives for sale:
  - (d) Licenses to keep a private magazine for the storage of explosives.
- (2) Notwithstanding anything to the contrary in the Explosives Regulations, every license to which this regulation applies which is granted or extended after the 30th day of June, 1942, whether before or after the commencement of these regulations, shall, unless sooner surrendered, cancelled, or revoked in accordance with the Explosives Regulations, continue in force until such date as the Minister of Internal Affairs may fix by notification published in the Gazette.
- (3) Any such notification may refer to all licenses to which this regulation applies, or to specified classes thereof, or to licenses issued to specified licensees or groups of licensees.

(4) No annual fee shall be charged for any license to which this regulation applies in respect of any period between the 30th day of June, 1943, and the expiry of the license pursuant to subclause (2) hereof unless the license is first issued after the 30th day of June, 1943, in which case only one annual fee shall be charged during that period.

(5) Nothing in this regulation shall be deemed to relieve any licensee from compliance with any of the requirements of the Explosives Regulations which shall, save as otherwise provided in this regulation, apply as if the license were issued

annually.

3. Notwithstanding anything to the contrary in clause 160 of the Explosives Regulations (as set out in the amending regulations made under the Explosive and Dangerous Goods Act, 1908, on the 10th day of December, 1930, and published in the Gazette on the 11th day of the same month\*), the fee to be charged for each importation license issued under the Explosives Regulations while these regulations continue in force shall be as follows:—

For every 2,000 lb. or portion of 2,000 lb. gross weight of explosives specified in the license, £3 10s.
