THE EDUCATION (GRADING OF PUBLIC SCHOOL TEACHERS) REGULATIONS AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1914, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Education (Grading of Public School Teachers) Regulations 1948, Amendment No. 3, and shall be read together with and deemed part of the Education (Grading of Public School Teachers) Regulations 1948* (hereinafter referred to as the principal regulations).
- 2. Regulation 7 of the principal regulations, as amended by regulations 3 and 4 of the Education (Grading of Public School Teachers) Regulations 1948, Amendment No. 1, is hereby further amended by revoking subclauses (2), (3), (3A), and (4), and substituting the following subclauses:
- "(2) Notwithstanding anything to the contrary in these regulations, no certificated teacher whose grading is 200 or less shall be credited with grading marks in excess of 200 unless that teacher has had at least three years' service in one or more of the following positions—namely, head teacher with one or more assistants; first male assistant, infant mistress, or senior woman assistant in a school with 351 or more pupils; senior assistant in the secondary department of a district high school with two or more assistants; senior organizer of the teaching of special subjects in such five education districts as are for the time being approved by the

Director for the purposes of this subclause by notice published in the Education Gazette; training college lecturer; senior assistant in an intermediate department attached to a school; or in other positions of equivalent responsibility.

"(3) Where grading marks assigned to a teacher at a general grading cannot be credited to that teacher before the next general grading by reason of the operation of this regulation, they shall not subsequently

be credited to that teacher:

"Provided that where a teacher complies with the requirements of subclause (2) of this regulation before the date on which the next general grading is deemed to be made, and applies in writing to the Director,—

"(a) If he complies with those requirements before the 1st day of February in the year following the last general grading, he shall be credited with the grading marks assigned to him at that grading as if he had complied with those requirements before that grading; and

"(b) If he complies with those requirements on or after the 1st day of February in the year following the last general grading, he shall be credited with the grading marks with which he would have been credited on the 1st day of February in that year if he had complied with those requirements before that

"(4) Where a teacher as a result of the grading marks assigned at any general grading may become credited with grading marks in excess of 200, the grading marks assigned to that teacher at that general grading shall not exceed 13 unless the teacher has shown ability to conduct

successfully a school of Grade V or higher."

3. Regulations 3 and 4 of the Education (Grading of Public School Teachers) Regulations 1948, Amendment No. 1, are hereby consequentially revoked.

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations vary regulation 7 of the principal regulations so as to remove the conditions affecting the crediting to teachers of grading marks in excess of 120, and vary the conditions affecting the crediting of grading marks in excess of 200. They also limit the grading marks which may be assigned to a teacher who has passed or is about to pass a grading of 200.
