## ORDER IN COUNCIL

At the Government House at Wellington this 1st day of December 1980

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

## ORDER

1. Title and commencement—(1) This order may be cited as the Education (Revocation of Spent Orders in Council) Order 1980.

(2) This order shall come into force on the 14th day after the date of its notification in the *Gazette*.

2. Revocation of spent Orders in Council—(1) Every Order in Council—

(a) Made before the 1st day of January 1936 under any former Education Act (within the meaning of the Education Act 1964); and

(b) Not specified in the First Schedule to this order, is hereby revoked.

(2) The regulations specified in the Second Schedule to this order are hereby revoked.
