ORDER IN COUNCIL

At the Government House at Wellington, this 22nd day of October, 1949

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Electoral Act, 1927, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Electoral Regulations 1928, Amendment No. 4, and shall be read together with and deemed part of the Electoral Regulations 1928* (hereinafter referred to as the principal regulations).

2. The Schedule to the principal regulations is hereby amended by revoking the forms numbered 6, 7, and 8, and substituting the forms set out in the Schedule to these regulations.

3. Regulation 6 of the principal regulations is hereby amended by omitting the words " or the form numbered 8", and also omitting the words " as the case may require ".
