ORDER IN COUNCIL

At Wellington this 24th day of March 1986

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Electoral Act 1956, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Electoral Regulations 1981, Amendment No. 5, and shall be read together with and deemed part of the Electoral Regulations 1981* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 7th day of April 1986.

- 2. Combination of exercise of Maori option with roll revision—(1) The principal regulations are hereby amended by inserting, after regulation 3A (as inserted by regulation 2(1) of the Electoral Regulations 1981, Amendment No. 1), the following regulation:
 - "3B. Every notice under section 43B of the Act shall be in form 3B."
- (2) The Schedule to the principal regulations is hereby amended by inserting, after form 3A (as inserted by regulation 2 (2) of the Electoral Regulations 1981, Amendment No. 1), the form 3B set out in the Schedule to these regulations.
- **3.** Inquiry about qualification for late enrolment—(1) Regulation 10 of the principal regulations is hereby amended by revoking subclause (1), and substituting the following subclause:
- "(1) Where any person applies for registration as an elector after writ day but before polling day in respect of any election (not being an application to which section 2 (3) or section 2 (4) of the Act applies), the following provisions of this regulation shall apply."
- (2) Regulation 10 (4) of the principal regulations is hereby amended by revoking paragraph (a), and substituting the following paragraph:
 - "(a) That the applicant—
 - "(i) Attained the age of 18 years after the 32nd day before writ day; and
 - "(ii) Is eligible for registration pursuant to section 50 of the Act; or".
- 4. Forms—(1) The Schedule to the principal regulations is hereby further amended by revoking form 1 (as substituted by regulation 2 of the Electoral Regulations 1981, Amendment No. 3), form 3, form 6, and form 12 (as substituted by regulation 5 of the Electoral Regulations 1981, Amendment No. 4), and substituting the forms 1, 3, 6, and 12 set out in the Schedule to these regulations.
- (2) The Schedule to the principal regulations is hereby further amended by omitting from form 16 the words "3 months", and substituting the words "1 month".
- **5. Revocations**—The following regulations are hereby consequentially revoked, namely:
 - (a) Regulation 3 of the Electoral Regulations 1981, Amendment No. 1:
 - (b) The Electoral Regulations 1981, Amendment No. 3:
 - (c) Regulation 5 (2) of, and the Schedule to, the Electoral Regulations 1981, Amendment No. 4.

Information for Electors

Registration compulsory

If you are gualified to register as an elector of an electorate, the law requires you to do so.

Qualifications

You are qualified to register if you-

- (a) Are a New Zealand citizen or a permanent resident of New Zealand (see definition below): and
- (b) Are 18 years of age or over; and
- (c) Have at some time resided continuously in New Zealand for 1 year or longer; and
- (d) Are not disqualified under the Electoral Act 1956.

Your electorate will be the last in which you have resided continuously for 1 month or, if you have never resided continuously in any one electorate for 1 month, the one in which you now reside or have last resided.

Permanent Resident of New Zealand

For electoral purposes a person is a permanent resident of New Zealand if, and only if, that

- (a) Resides in New Zealand: and
- (b) Is not a prohibited immigrant or a person obliged, by or pursuant to any Act, to leave New Zealand immediately or within a specified time.

Disqualifications

You are NOT qualified to register if you-

- (a) Are a New Zealand citizen who (not being a public servant on duty or a member of the family of a public servant on duty) is outside New Zealand and has not been in New Zealand within the last 3 years; or
- (b) Are a permanent resident of New Zealand who (not being a public servant on duty or a member of the family of a public servant on duty) is outside New Zealand and has not been in New Zealand during the last 12 months; or
- (c) Are detained under the Criminal Justice Act 1985 as either a special or committed patient in a hospital under the Mental Health Act 1969; or
- (d) Are detained, because of a conviction, in a penal institution or a hospital under the Mental Health Act 1969: or
- (e) Are named on an electoral Corrupt Practices List.

Truth

You must satisfy yourself that the statements in the application are true.

Signing the application

You MUST sign the card YOURSELF unless you are physically disabled. Only if you are physically disabled, may the application be signed on your behalf-

- (a) By a person who holds a power of attorney from you and who indicates on the form that you are a physically disabled person; or
- (b) By a registered elector who signs by your direction and who indicates on the form-(i) That you are a physically disabled person; and
 - (ii) That the form is being signed by your direction.

Change of address Every time you change your address, you must give your new address to the Registrar of Electors. Change of address forms are kept at every Post Office.

New Zealand Maori Option



- If you are a New Zealand Maori or a descendant of a New Zealand Maori, you may have the option of choosing between a General electorate or a Maori electorate. Everyone else must register for a General electorate.
- The option is available to you if-
- (a) You have never registered as an elector before; or (b) You were not registered as an elector on [Insert datel and you have not registered since.

Inquiry about Qualification for Late Enrolment

Dear Applicant

I received your application for registration as an elector of the (Note 1) electorate AFTER the time set by law for the closing of the rolls.

As your name will not appear on the printed roll, you should show the written confirmation when you attend to vote. If you have not received your confirmation by polling day, you may still cast a special vote.

NOTES

- 1. Insert the name of electoral district.
- 2. Insert date fixed by reference to section 50 (2) of the Electoral Act 1956.

Under that subsection late enrolment is permitted if the applicant becomes qualified for registration after the 32nd day before writ day. Accordingly if, for example, 14 November 19 were writ day, the day to be inserted here would be 13 October 19 .

- 3. Insert the date of the ninth day after polling day.
- 4. Here insert the date which is one month before the date inserted under Note 2. Accordingly if, for example, that date were 13 October 19 , the date to be inserted here would be 13 September 19 .
- 5. Here insert the date which is 1 year before the date inserted under Note 2. Accordingly if, for example, that date were 13 October 1990, the date to be inserted here would be 13 October 1989.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 7 April 1986, prescribe for the purposes of the Electoral Act 1956, the following new forms:

- (a) Form 1: Application for registration as an elector:
- (b) Form 3: Notice of registration as an elector:
- (c) Form 3B: Roll revision and Maori option:
- (d) Form 6: Parliamentary Electoral roll: Change of electorate:
- (e) Form 12: Parliamentary electors: Inquiry about qualification for late enrolment.

The new forms reflect changes made to the Electoral Act 1956 by the Electoral Amendment Act 1985 and the Electoral Amendment Act (No. 2) 1985.
