# **THE EMERGENCY RESERVE CORPS ENROLMENT ORDER 1942**

PURSUANT to Regulation 8A of the National Service Emergency Regulations 1940,\* the Minister of National Service doth hereby order and direct as follows :---

1. This Order may be cited as the Emergency Reserve Corps Enrolment Order 1942.

2. Subject to the exemptions hereinafter specified, every male British subject who at the date of this Order is a member of the General Reserve constituted by Regulation 5 of the National Service Emergency Regulations 1940\* and is not a member of any branch of the Emergency Reserve Corps established by the Emergency Reserve Corps Regulations 1941<sup>+</sup> shall, within fourteen days after the date of this Order, apply for enrolment in the Emergency Reserve Corps, and upon being accepted for any branch of the Corps shall serve as a member of that branch.

3. Subject to the exemptions hereinafter specified, every male British subject who at any time after the date of this Order becomes a member of the General Reserve and is not at that time a member of the Emergency Reserve Corps shall, within fourteen days thereafter, apply for enrolment in the Emergency Reserve Corps, and upon being accepted for any branch of the Corps shall serve as a member of that branch.

4. Every person who for the time being belongs to any one or more of the classes specified in the Schedule hereto shall be exempt from compliance with clause 2 or clause 3 of this Order.

5. If at any time after the date of this Order any person ceases to be exempted under the last preceding clause from compliance with clause 2 or clause 3 of this Order and is not at that time a member of the Emergency Reserve Corps he shall, within fourteen days thereafter, apply for enrolment in the Emergency Reserve Corps, and upon being accepted for any branch of the Corps shall serve as a member of that branch.

### SCHEDULE.

#### EXEMPTIONS.

MEN who have not attained the age of eighteen years.

Men who have attained the age of sixty-six years.

Men who are outside New Zealand.

Men in receipt of invalids' benefits under the Social Security Act, 1938.

Inmates of any hospital or of the New Zealand Institute for the Blind.

Men in respect of whom reception-orders are in force under the Mental Defectives Act, 1911\* (whether or not they are detained in institutions under that Act),

or who are detained as voluntary boarders under that Act.

Men undergoing sentences of imprisonment or detained in Borstal institutions. Members of the Home Guard.

Men actively attached to any of His Majesty's naval, military, or air forces.
