



THE EMPLOYMENT RESTRICTION ORDER NO. 5

PURSUANT to Regulation 30 of the Industrial Man-power Emergency Regulations 1944,* the Minister of Industrial Man-power doth hereby make the following Order.

ORDER

1. This Order may be cited as the Employment Restriction Order No. 5, and shall come into force on the 16th day of November, 1944.
2. (1) The Employment Restriction Order No. 4† is hereby revoked.
(2) The revocation of the said Order shall not affect the liability of any person for any offence in relation thereto committed before the coming into force of this Order.

APPLICATION OF THIS ORDER

3. This Order applies to all persons who are for the time being engaged, whether as principals or agents or as employers or servants, in carrying on any industry, trade, or occupation within any of the areas specified in the First Schedule hereto.

DIRECTIONS TO PERSONS TO WHOM THIS ORDER APPLIES

4. Except with the prior consent in writing of a District Man-power Officer, no person to whom this Order applies shall engage or attempt to engage any worker, for employment in any area specified in the First Schedule hereto, otherwise than in employment of a kind or class referred to in the Second Schedule hereto.

SCHEDULES

FIRST SCHEDULE

AREAS WITHIN WHICH THE RESTRICTIONS IMPOSED BY THIS ORDER APPLY

Cities and Adjoining Areas

THE City of Auckland, the Boroughs of Birkenhead, Devonport, Ellerslie, Mount Albert, Mount Eden, New Lynn, Newmarket, Northcote, Onehunga, One Tree Hill, Otahuhu, and Takapuna, and the Road Districts of Mount Roskill, Mount Wellington, and Panmure Township.

The City of Christchurch, the Boroughs of Lyttelton, Riccarton, and Sumner, and the Counties of Halswell, Heathcote, Paparua, and Waimairi.

The City of Dunedin, and the Boroughs of Green Island, Port Chalmers, St. Kilda, and West Harbour.

 The Cities of Wellington and Lower Hutt, the Boroughs of Eastbourne and Petone, and the Johnsonville Town District.

SECOND SCHEDULE

CLASSES OF EMPLOYMENT EXCLUDED FROM THE RESTRICTIONS IMPOSED BY THIS ORDER

1. Employment on any land that is used for commercial purposes as an orchard, or as a poultry-farm, dairy-farm, sheep-farm, mixed farm, or other farm (where the scope of the employment of the persons employed comprises any of the following operations—namely, any work involved in dairy-farming or in poultry-farming; or in the sowing, raising, harvesting, or treating of grain, fodder, fruit, tobacco, or farm produce; or in the management, rearing, or grazing of cattle, sheep, or other live-stock; or in the shearing or crutching of sheep or the classing, scouring, sorting, or pressing of wool; or any other work done on and for the purposes of the orchard or farm).

2. Employment in any market-garden used for the production of vegetables for sale.

3. Employment in any capacity on any ship, hulk, lighter, barge, or other vessel; or employment on any wharf, pier, or jetty in connection with the loading or unloading of any vessel.

4. Employment as a midwife, or maternity nurse, or as a professional nurse for the sick.

5. Employment in any institution under the control of a Hospital Board, or in any licensed private hospital, or in any mental hospital.

6. Employment in any coal-mine.

7. Employment on casual work for a period not exceeding three consecutive days.
