



THE EGG RATIONING PERMIT 1944

PURSUANT to the Rationing Emergency Regulations 1942,* the Rationing Controller hereby grants the following permit :—

1. (1) This permit may be cited as the Egg Rationing Permit 1944, and shall be deemed to have come into force on the 20th day of March, 1944.

(2) The Egg Rationing Permit 1943† is hereby revoked.

2. In this permit,—

“Egg rationing district” means a district specified in the Schedule to this permit :

“Preferential consumer” means a person to whom a preference ration document for eggs has been issued by the Rationing Controller :

“The regulations” means the Rationing Emergency Regulations 1942.*

3. Any retailer, in the course of any business carried on by him, may supply eggs to any consumer without the surrender or cancellation of any coupons and notwithstanding that the retailer may not be licensed or that the consumer may not be registered under the regulations—

(a) Where the retailer's shop or other place of business is not in any egg rationing district ; or

(b) Where the eggs so supplied are surplus eggs remaining in the hands of the retailer after he has set aside for his registered preferential consumers all eggs to which they are entitled during the week in which the surplus eggs are supplied as aforesaid.

4. Nothing in this permit shall excuse any person from compliance with any directions of the Rationing Controller under the regulations, or from compliance with any restrictions or obligations imposed by or under any Act, or by or under any other regulations.

SCHEDULE

EGG RATIONING DISTRICTS

1. *The Auckland Egg Rationing District.*—All that area comprising the Auckland Egg Marketing Area under the Egg Marketing Regulations 1940‡, as redefined by notice in the *Gazette* of the 24th day of September, 1942, at page 2415.

2. *The Wellington Egg Rationing District.*—All that area comprising the Wellington Egg Marketing Area under the Egg Marketing Regulations 1940, as redefined by notice in the *Gazette* of the 19th day of June, 1942, at page 1651.

3. *The Christchurch Egg Rationing District.*—All that area comprising the Christchurch Egg Marketing Area under the Egg Marketing Regulations 1940, as redefined by notice in the *Gazette* of the 19th day of November, 1942, at page 2766.

4. *The Dunedin Egg Rationing District.*—All that area comprising the Dunedin Egg Marketing Area under the Egg Marketing Regulations 1940.

5. *The Hawke's Bay Egg Rationing District.*—All that area comprising the Hawke's Bay Egg Marketing Area under the Egg Marketing Regulations 1940, as defined by notice in the *Gazette* of the 28th day of August, 1941, at page 2702, together with all that area of land within the counties of Patangata, Waipukurau, and Waipawa.

6. *The New Plymouth Egg Rationing District.*—All that area of land lying within a radius of eight miles from the New Plymouth Post-office.

7. *The Wanganui Egg Rationing District.*—All that area of land within the City of Wanganui, together with all that area of land lying within the Mosston Riding of the Waitotara County as defined in the *Gazette* of 17th January, 1929, at page 136.

8. *The Palmerston North Egg Rationing District.*—All that area of land lying within a radius of five miles from the Palmerston North Post-office.

9. *The North Wairarapa Egg Rationing District.*—All that area of land lying within a radius of four miles from the post-office in each of the following towns: Masterton, Pahiatua, Alfredton, Pongaroa, Tinui, and Mauriceville, together with that area of land lying within a radius of eight miles from the Eketahuna Post-office.

10. *The South Wairarapa Egg Rationing District.*—All that area of land lying within a radius of four miles from the post-office in each of the following towns: Carterton, Greytown, Martinborough, Featherston, and Pirinoa.

11. *The Blenheim Egg Rationing District.*—All that area of land in the Marlborough Land District within a radius of thirteen miles from the Market Square, Blenheim, together with the townships of Seddon, Okaramio, and Koromiko.

12. *The Timaru Egg Rationing District.*—All that area of land lying within the Borough of Timaru, together with all that area of land within the following boundaries: commencing at a point at the intersection of Kelland's Hill Road and Page's Road; thence in a northerly direction along Kelland's Hill Road to the intersection of Washdyke Flat Road; thence in an easterly direction along Washdyke Flat Road to the intersection of Main North Road; thence in a southerly direction along Main North Road to the intersection of Old North Road; thence in a southerly direction along Old North Road to the intersection of Page's Road; thence in a westerly direction along Page's Road to Kelland's Hill Road, the point of commencement.

13. *The Invercargill Egg Rationing District.*—All that area in the Southland Land District bounded by a line commencing at the intersection of the Waikiwi Stream and the eastern side of the Makarewa-Invercargill Railway; thence in a southerly direction along the eastern side of the said railway to and across the Waihopai River; thence southerly generally by the Waihopai River to its intersection by Kingswell Creek; thence easterly generally up Kingswell Creek to its intersection with Elles Road; thence northerly along Elles Road to its intersection with McQuarry Street; thence easterly along McQuarry Street to its intersection with Boundary Road; thence northerly along Boundary Road to its intersection with Oteramika Road, and again northerly generally along Racecourse Road to the Waihopai River; thence westerly generally down the Waihopai River to its intersection with Elles Road; thence northerly along Elles Road to its intersection with Bainfield Road; thence westerly along Bainfield Road to its intersection with North Road; thence northerly along North Road to its intersection with Waikiwi Stream; thence westerly down the Waikiwi Stream to its intersection with the Makarewa-Invercargill Railway, the point of commencement.
