THE EDUCATION (SALARIES AND STAFFING) REGULATIONS 1957, AMENDMENT NO. 6

ORDER IN COUNCIL

Pursuant to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Education (Salaries and Staffing) Regulations 1957, Amendment No. 6, and shall be read together with and deemed part of the Education (Salaries and Staffing) Regulations 1957* (hereinafter referred to as the principal regulations).
- 2. Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "Director".
- 3. Regulation 12 of the principal regulations is hereby amended by inserting, after subparagraph (i) of paragraph (a) of subclause (1), the following subparagraph:
 - "(ia) As a full time tutor in a technical institute:".
- 4. (1) Regulation 20 of the principal regulations is hereby further amended by omitting from subclause (2) the words "roll number" and substituting the words "grading roll".
- (2) Regulation 20 of the principal regulations is hereby further amended by adding the following subclause:

- "(3) For the purpose of this Part of these regulations, the grading roll for the school or department shall be—
 - "(a) In the case of a full primary school, a contributing school, a Maori school, an intermediate school or department, or the primary department of a district high school, the roll of the school at the 30th day of September of the year immediately preceding the year to which the grading applies; or, if the school or department is then closed, at the first day thereafter on which the school or department is open, the roll to be assessed in such manner as the Director-General may from time to time determine by notice in the Education Gazette:
 - "(b) In the case of the secondary department of a district high school, the roll of the department on the 1st day of March in the year to which the grading applies; or, if the department is closed on that day, the number of pupils on the roll of the department on the first day on which the school is open after the 1st day of March; and in ascertaining the roll number no pupil shall be included who was not in attendance at any time during the 10 school days immediately preceding the 1st day of March, or if the school has not been open for 10 school days immediately preceding the 1st day of March, then during the first 10 school days in that year:

"Provided that no pupil shall be excluded if he had previously been in attendance and if his name was entered on the roll in good faith and his non-attendance was due

to sickness or accident."

- 5. (1) The principal regulations are hereby amended by revoking regulation 21, as amended by regulation 6 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 1, and substituting the following regulation:
- "21. (1) The grade or subgrade of any school or department to which this Part of these regulations applies shall, on and after the 1st day of February in each year, be determined according to the grading roll of the school.
- "(2) The Board may, with the approval of the Senior Inspector, classify any school or department in a grade or subgrade lower, or in a grade or subgrade higher, than the grade or subgrade appropriate for its grading roll, if it is satisfied that the roll number is not likely to be permanent:

"Provided that a school or department shall not be so classified in a grade or subgrade lower or higher than the grade appropriate for its grading roll for a period longer than one year without the approval of the Director-General."

- (2) Regulation 6 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 1, is hereby consequentially revoked.
- 6. (1) The principal regulations are hereby amended by revoking regulation 29, as substituted by regulation 3 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 3, and substituting the following regulation:

"29. The Board may, with the approval of the Senior Inspector, appoint another assistant if for any consecutive period of four weeks the average roll increases to a number which, if it were the grading

roll, would have entitled the school to another assistant:

"Provided that, where any increase occurs in the roll number of a school, the Board may, with the approval of the Senior Inspector, add an assistant to the staff of the school at any time before the expiry of the period of four consecutive weeks, if the Board and the Senior Inspector are satisfied that the increase is a permanent one."

- (2) Regulation 3 of the Education (Salaries and Staffing) Regulations 1957, Amendment No. 3, is hereby consequentially revoked.
- 7. Regulation 42 of the principal regulations is hereby amended by omitting the words "average roll", and substituting the words "grading roll".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for a new procedure for determining the grading roll of a full primary school, a contributing school, a Maori school, an intermediate school or department, or a district high school.
