# ORDER IN COUNCIL

At the Government Buildings at Wellington this 25th day of June 1979

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Economic Stabilisation (Conservation of Petroleum) Regulations (No. 2) 1979, Amendment No. 2, and shall be read together with and deemed part of the Economic Stabilisation (Conservation of Petroleum) Regulations (No. 2) 1979\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Commencement of Part II of the principal regulations—Regulation 1 of the principal regulations is hereby amended by revoking subclause (4) (as added by regulation 2 (2) of the Economic Stabilisation (Conservation of Petroleum) Regulations (No. 2) 1979, Amendment No. 1), and substituting the following subclause:

"(4) Regulations 14 (1) and 14 (3) of these regulations shall come into force on the 30th day of July 1979."

3. Application of Part II of the principal regulations—Regulation 13 (2) (g) of the principal regulations (as substituted by regulation 6 (2) of the Economic Stabilisation (Conservation of Petroleum) Regulations (No. 2) 1979, Amendment No. 1) is hereby amended by revoking subparagraph (xi), and substituting the following subparagraphs:

"(xi) An owner of a gas undertaking within the meaning of section 2 of the Gas Industry Act 1958; or

"(xii) The traffic enforcement branch of a local authority,—".

4. Essential users—(1) Part I of the Second Schedule to the principal regulations is hereby amended by revoking the clause 21 added by regulation 15 (2) of the Economic Stabilisation (Conservation of Petroleum) Regulations (No. 2) 1979, Amendment No. 1.

(2) Part I of the Second Schedule to the principal regulations (as amended by regulation 15 (2) of the Economic Stabilisation (Conservation of Petroleum) Regulations (No. 2) 1979, Amendment No. 1) is hereby amended by adding the following clause:

"26. A driver of a rubbish collection motor vehicle".

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Economic Stabilisation (Conservation of Petroleum) Regulations (No 2) 1979.

Regulation 2 postpones the commencement of the provisions requiring the displaying of carless day stickers. These provisions (which were to have come into force on 1 July 1979) will now come into force on 30 July 1979.

*Regulation 3* exempts from the carless day provisions any motor vehicle operated by the traffic enforcement branch of a local authority and emblazoned with words or markings or both indicating the body by which the motor vehicle is operated.

*Regulation 4* renumbers the clause in Part I of the Second Schedule to the principal regulations which makes a driver of a rubbish collection vehicle an essential user within the meaning of those regulations.
