THE ELECTRICAL SUPPLY REGULATIONS 1935, AMENDMENT NO. 12

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Electrical Supply Regulations 1935, Amendment No. 12, and shall be read together with and deemed part of the Electrical Supply Regulations 1935* (hereinafter referred to as the principal regulations).
- 2. (1) Regulation 27–14 of the principal regulations is hereby amended by revoking subclause (1), and substituting the following subclause:
- "(1) Provided the licensee has legal power so to do, the licensee shall, if so required, sell to the Crown the licensee together with the whole of the business and undertaking of the licensee so far as it relates to or is connected with the exercise of the licence, and together with all real and personal property and all rights vested in the licensee and used or engaged in connection with the business or undertaking so to be purchased (all hereafter in this regulation referred to as the undertaking)."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend regulation 27-14 of the Electrical Supply Regulations 1935 so as to make the option to purchase certain electrical undertakings conferred by that regulation exercisable only by the Crown.
