**THE ELECTRICAL SUPPLY REGULATIONS 1935,  
AMENDMENT NO. 8**

ORDER IN COUNCIL

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Public Works Act, 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Electrical Supply Regulations 1935, Amendment No. 8, and shall be read together with and deemed part of the Electrical Supply Regulations 1935\* (hereinafter called the principal regulations).

2. Regulation 22-22 of the principal regulations is hereby amended by revoking clause (3) thereof.

3. Regulation 41-38 of the principal regulations is hereby revoked.

4. Regulation 41-53 of the principal regulations is hereby amended by omitting the words " or extra-high pressure ".

5. Regulation 41-76 of the principal regulations is hereby amended by revoking paragraph (d) of clause (3), and substituting the following paragraph :—

" (d) Where double cross-arms, each fitted with pin-type insulators are used and the forces due to the angle are, as far as possible, divided equally between the insulators."

6. Regulation 45-05 of the principal regulations, as amended by Regulation 13 of the Electrical Supply Regulations 1935, Amendment No. 4, is hereby further amended as follows :—

(a) By omitting from paragraph (f) the words " and as far as practicable shall be located in accordance with the drawings shown in Folders Nos. 1 and 2, Appendix III, hereto ".

(b) By omitting from paragraph (h) the words " This subparagraph shall be read in conjunction with the drawings shown on Folders Nos. 1 and 2 in Appendix III hereto ".

(c) By omitting from item (iv) of the table set out in paragraph (o) the words " This subparagraph shall be read in conjunction with the drawing shown in Folder No. 3 in Appendix III hereto ".

7. Regulation 46-14 of the principal regulations is hereby amended by omitting the words "The foregoing regulation shall be read in conjunction with the drawing shown on Folder No. 4 in Appendix III hereto".

8. Regulation 21 of the Electrical Supply Regulations 1935, Amendment No. 4, is hereby revoked.

EXPLANATORY NOTE

*[This note is not part of the regulations, but is intended to indicate their general effect.]*

Regulations 2-5 make technical amendments of the existing regulations relating to initial installations, and to clearances and supports for power lines.

Regulations 6-8 omit from the existing regulations references to certain diagrams and folders which showed the methods of clearance by power lines of telephone lines and railway aerial wires.
