**THE ECONOMIC STABILIZATION REGULATIONS 1952,

**ORDER IN COUNCIL**

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Economic Stabilization Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

1. These regulations may be cited as the Economic Stabilization Regulations 1952, Amendment No. 1, and shall be read together with and deemed part of the Economic Stabilization Regulations 1952\* (hereinafter referred to as the principal regulations).

2. Regulation 2 of the principal regulations is hereby amended by adding the following new definition:—

“ ‘Tribunal’ means the Government Service Tribunal established under the Government Service Tribunal Act 1948, the Government Railways Industrial Tribunal established under the Government Railways Act 1949, or the Waterfront Industry Tribunal established under the Waterfront Industry Emergency Regulations 1946†.”

3. Regulation 5 of the principal regulations is hereby amended by inserting in subclause (5), after the words “awards and industrial agreements”, the words “or by orders of Tribunals”.

4. Regulation 8 of the principal regulations is hereby amended by inserting in subclause (5), after the words “awards and industrial agreements”, the words “or by orders of Tribunals”.

## EXPLANATORY NOTE

*[This note is not part of the regulations, but is intended to indicate their general effect.]*

These regulations amend the Economic Stabilization Emergency Regulations 1952, so as to enable representatives of the parties bound by orders of the Government Service Tribunal, the Government Railways Industrial Tribunal, and the Waterfront Industry Tribunal to appear and make submissions on the hearing by the Court of Arbitration of applications for general orders increasing or reducing rates of remuneration, or of applications for standard wage pronouncements.
