THE ELECTRICAL SUPPLY REGULATIONS 1984, AMENDMENT NO. 2

ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Electricity Act 1968, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Electrical Supply Regulations 1984, Amendment No. 2, and shall be read together with and deemed part of the Electrical Supply Regulations 1984* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1987.

2. Interpretation—(1) Regulation 2 (1) of the principal regulations is hereby amended by revoking the definition of the term "District Engineer, Post Office".

(2) Regulation 2(1) of the principal regulations is hereby further amended by inserting, after the definition of the term "supply system", the following definition:

"'Telecom' means the Telecom Corporation of New Zealand Limited:".

3. Location of lines—Regulation 16 (1) (c) of the principal regulations is hereby amended by omitting the words "Ministry of Energy", and substituting the words "Electricity Corporation of New Zealand Limited".

4. Amendments consequential upon the establishment of Telecom—(1) The principal regulations are hereby amended—

- (a) By omitting from regulations 16, 55, 56, 111, and 112 the words "the District Engineer, Post Office" wherever they occur, and substituting in each place the words "an officer of Telecom authorised in writing by Telecom for the purpose":
- (b) By omitting from regulations 93 (2), 99, 109, 112, 113, and 120 the words "the Post Office" wherever they occur, and substituting in each place the word "Telecom":
- (c) By omitting from regulations 97, 117 and 119 the words "Post Office", and substituting the word "Telecom".

5. Amendments consequential upon the establishment of the Electricity Corporation of New Zealand Limited—The principal regulations are hereby amended—

- (a) By omitting from regulations 22 and 120 the words "Electricity Division of the Ministry of Energy, wherever they occur, and substituting in each place the words "Electricity Corporation of New Zealand Limited":
- (b) By omitting from regulation 120 (1) (b) the word "Departments", and substituting the word "organisations":

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect. These regulations amend the Electrical Supply Regulations 1984 to take account of the establishment of the Telecom Corporation of New Zealand Limited and the Electricity Corporation of New Zealand Limited.
