



THE FISHERIES (1985-86 COMMERCIAL PAUA QUOTAS ALLOCATION) NOTICE 1986

PURSUANT to regulation 5 of the Fisheries (Commercial Quotas and Restrictions) Regulations 1986, the Minister of Fisheries hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (1985-86 Commercial Paua Quotas Allocation) Notice 1986.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Application—The allocations of quota for paua in this notice shall apply in respect of the year that commenced with the 1st day of October 1985.

3. Allocation of quotas—There is hereby allocated to each commercial fisherman named in the Schedule to this notice so much of the total paua quota prescribed in regulation 4 of the Fisheries (Commercial Quotas and Restrictions) Regulations 1986^{*} as is specified opposite the name of that commercial fisherman for the appropriate areas specified in the Schedule to this notice.

4. Revocation—The Fisheries (Commercial Paua Quotas Allocation) Notice 1985 (S.R. 1985/251) is hereby revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice is made under regulation 5 of the Fisheries (1985-86 Commercial Quotas and Restrictions) Regulations 1986 (S.R. 1986/97) which is authorised by section 89(1)(g) of the Fisheries Act 1983.

The regulations set a total quota for paua of 1183.380 tonnes which is an increase of 12.380 tonnes over that set under the former regulations. The regulations now divide the quota among various areas, and this notice allocates the quotas to commercial fishermen for taking within those areas.

The 20.905 tonnes of paua quota for the Auckland area is unallocated and is therefore available for competitive fishing.
