THE FISHERIES (1998-94 JACK MACKEREL QUOTA ALLOCATION) NOTICE 1993

PURSUANT to the Fisheries (1993-94 Jack Mackerel Quota) Regulations 1993, the Minister of Fisheries hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Fisheries (1993–94 Jack Mackerel Quota Allocation) Notice 1993.
- (2) This notice shall come into force on the day after the date of its notification in the Gazette.
- 2. Allocation of jack mackerel quotas—(1) The quota imposed by the Fisheries (1993–94 Jack Mackerel Quota) Regulations 1993 on the taking of jack mackerel in the Part Auckland (East), Central (East) Area is hereby allocated as set out in Part I of the Schedule to this notice.
- (2) The quota imposed by the Fisheries (1993-94 Jack Mackerel Quota) Regulations 1993 on the taking of jack mackerel in the South-East, Southland, Sub-Antarctic Area is hereby allocated as set out in Part II of the Schedule to this notice.
- **3. Revocation**—The Fisheries (1991–92 Jack Mackerel Quota Allocation) Notice 1991 (S.R. 1991/246) is hereby revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the Gazette, is made under the Fisheries (1993-94 Jack Mackerel Quota) Regulations 1993. Those regulations have effect until the close of 30 September 1994.

The notice allocates to individual commercial fishermen the quotas imposed by those regulations on the taking of jack mackerel by commercial fishermen, being-

- (a) 5,970 greenweight tonnes for the Part Auckland (East), Central (East) Area:
- (b) 2,700 greenweight tonnes for the South-East, Southland, Sub-Antarctic Area. The unallocated portion for each area is as follows:

- (a) 1,155.6 greenweight tonnes for the Part Auckland (East), Central (East) Area:
- (b) 561.8 greenweight tonnes for the South-East, Southland, Sub-Antarctic Area.

 The unallocated portion for each area may be taken by commercial fishermen who have not received any allocation of quota for the area or who have filled their allocations for the

area.

The total greenweight of fish allocated by this notice is unchanged from that applying in the 1991-92 fishing year.
