



**FISHERIES (1997 FOVEAUX STRAIT DREDGE OYSTER QUOTA
ALLOCATION) NOTICE 1997**

PURSUANT to regulation 5 of the Fisheries (1997 Foveaux Strait Dredge Oyster Quota) Regulations 1997*, the Minister of Fisheries gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Fisheries (1997 Foveaux Strait Dredge Oyster Quota Allocation) Notice 1997.

(2) This notice comes into force on 1 June 1997.

2. Allocation of dredge oyster quota—The quota imposed by regulation 4 of the Fisheries (1997 Foveaux Strait Dredge Oyster Quota) Regulations 1997 on the taking of dredge oysters in the Foveaux Strait dredge oyster fishery is allocated as set out in the Schedule of this notice.
