



## Fisheries (Interim and Annual Deemed Values) Notice 2003

Pursuant to section 75 of the Fisheries Act 1996, the Minister of Fisheries, after consultation in accordance with section 75A of that Act, gives the following notice.

### Notice

#### 1 Title

This notice is the Fisheries (Interim and Annual Deemed Values) Notice 2003.

#### 2 Commencement

This notice comes into force on 30 September 2003.

#### 3 Application

This notice applies to fish taken on or after 1 October 2003.

#### 4 Interpretation

(1) In this notice,—

**ACE** means annual catch entitlement

**Act** means the Fisheries Act 1996

**reported catch** has the same meaning as in the Fisheries (Deemed Value and Notification of Balances) Regulations 2001.

- (2) The references in the first columns of Schedules 1 and 2 of this notice are references to the fishstock codes described in Part 1 of Schedule 3 of the Fisheries (Reporting) Regulations 2001.
- (3) References to amounts per kilogram include references to amounts per oyster, in the case of Foveaux Strait dredge oysters.

## 5 Interim deemed values

The interim deemed values to be demanded by the chief executive under section 76(2) of the Act for the stocks specified in the first column of Schedule 1 are the amounts per kilogram specified for those stocks in the second column of that schedule, except as otherwise provided in clause 7 in relation to the Chatham Islands.

## 6 Annual deemed values

Subject to clause 7, the annual deemed values to be demanded by the chief executive under section 76(2A) and (2B) of the Act for the stocks specified in the first column of Schedule 1 are,—

- (a) in the case of all stocks of anchovy, cardinal fish, frostfish, garfish, ghost shark, leatherjacket, paddle crab, pilchard, ribaldo, ruby fish, sea perch, skate, sprat, trumpeter, white warehou, and yellow-eyed mullet, and also in the case of the individual stocks SCH 2, SPO 2, SWA 3, SWA 4, STA 1, STA 2, and TRE 2, the amounts per kilogram specified for those stocks in the third column of Schedule 1:
- (b) in the case of all other stocks,—
  - (i) for so much of the commercial fisher's reported catch as does not exceed the fisher's ACE by more than 20%, the amounts per kilogram specified for those stocks in the third column of Schedule 1 (the **basic annual deemed value**):
  - (ii) for so much of the commercial fisher's reported catch as exceeds the fisher's ACE by more than

- 20% but not more than 40%, 120% of the basic annual deemed value:
- (iii) for so much of the commercial fisher's reported catch as exceeds the fisher's ACE by more than 40% but not more than 60%, 140% of the basic annual deemed value:
  - (iv) for so much of the commercial fisher's reported catch as exceeds the fisher's ACE by more than 60% but not more than 80%, 160% of the basic annual deemed value:
  - (v) for so much of the commercial fisher's reported catch as exceeds the fisher's ACE by more than 80% but not more than 100%, 180% of the basic annual deemed value:
  - (vi) for so much of the commercial fisher's reported catch as exceeds the fisher's ACE by more than 100%, 200% of the basic annual deemed value.

## **7 Different deemed values for Chatham Islands**

- (1) Despite clauses 5 and 6, the interim deemed values and basic annual deemed values specified for the stocks listed in the first column of Schedule 2 apply in respect of fish, aquatic life, and seaweed landed in the Chatham Islands and received by a licensed fish receiver located on the Chatham Islands.
- (2) Except in the case of sea perch and trumpeter, clause 6(b) applies to stocks landed in and received by a licensed fish receiver located in the Chatham Islands as if references in that clause to Schedule 1 were references to Schedule 2.

## **8 Revocation**

- (1) The Fisheries (Interim and Annual Deemed Values) Notice 2002 (SR 2002/313) is revoked.
  - (2) Despite subclause (1), that notice continues to apply to fish taken on or after 1 October 2002 and before 1 October 2003.

#### Explanatory note

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which takes effect on 1 October 2003, sets interim and annual deemed values for stocks caught on or after that date within the quota management system. Different rates are set for the Chatham Islands for certain stocks.

For most stocks, a basic annual deemed value is set for so much of a commercial fisher's reported catch as does not exceed the fisher's ACE by more than 20%, but the deemed value increases as higher steps of excess catch are reached.
